A Brief History of "One-World Government" Groups

GENOCIDE PLANS BASED ON GREED: THE CLUB OF ROME

The depopulation programs discussed herein are part of a vast network initiated by world social planners in an effort to rid the Earth of some 2 to 3 billion human beings by the year 2000. Although population control is nothing new, the methods these social planners are currently using throughout the world are, to say the least, abhorant to those who cherish life and liberty.

The overall genocide plans involve governments, corporations and private institutions. The plans (officially) stem from an 800-page Carter Administration report detailing the deteriorating conditions of Earth's environment, as well as the need to halt population growth. The government study—called "Global 2000 Report"—is based on the "Malthusian theory" that populations grow faster than food sources, resulting in famine, war, disease, and other devastations such as pollution. The report was submitted by the State Dept. and the Council on Environmental Quality—it was rejected by the Reagan Administration, although former Sec. of State Henry Kissinger has attempted to rewrite the govt. report selling depopulation as a "national security imperative", stressing "America First" rhetoric. Kissinger's headquarters for this project is the Georgetown University Center for Strategic and International Studies (CSIS), according to the 3/10/81 'New Solidarity' newspaper report.**

AURELIO PECCEI— CZAR OF GENOCIDE



The idea to use mass-genocide to "solve" the over-population problem was actually originated some 10 years ago by the Club of Rome, a world-wide organization founded in 1968 by an Italian industrialist, Aurelio Peccei, and is composed of millionaires, billionaires, politicians and other powerful members of the global elite. The Club of Rome's recent U.S. effort was made in Washington, D.C. on March 2 in a day-long seminar to drum up support for a "new international economic order" with "new forms of government" taking control, according to a C of R spokesman. But their policies include far more than mere speechwriting and economic global planning—according to Club of Rome administrators of late, the world is simply too crowded with non-producing "eaters", which must be eliminated, according to 'The SPOTLIGHT' newspaper (3/22/82).**

"CLUB" SEEKS TO MANAGE WORLD

The Club of Rome is actually part of a much larger organization (discussed later) which has taken upon itself the task of planning in great detail the world's future—even to the point of deciding who will live and die! The C of R mass-genocide policies—along with the Club's global, economic, industrial, agricultural, political management—rely mainly on computer analyses, which tell them which sectors of the world should be depopulated and how to go about it. One of the Club's computer research facilities in the U.S. is at the Missouri Institute of Technology (MIT). According to an article written by Peccei (also the Club's president) for 'Futurist' magazine,** Club projects are "now being tested in many countries." Peccei believes that "culturally and behaviorally (mankind) is lagging" and that survival and the road to survival is

privity to "those who command knowledge and power"--namely, elite groups such as the Club of Rome. As is the case with all C of R members, Peccei touts One-Worldism--which he calls "global community"--as the solution to the Malthusian problems the world faces. The very same One-World Government concept has been the prime goal of such notorious figures as Stalin, Lennin, Marx, Hitler, Mussolini, Napoleon, and lesser philosophers who believed the world should be "managed" by a handful of "benevolent dictators". Today, One-Worldism can be seen developing in the world's computerized economic system of the International Monetary Fund (electronic banking) as implemented by the member nations of the Common Market. In modern times, however, One-World implementation through governments is much more elusive/clandestine, as explained in the next section.

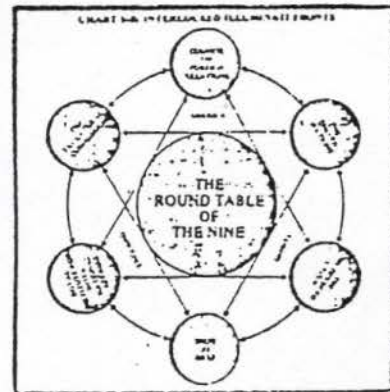
GLOBAL 2000 HAS "ONE-WORLD" ROOTS

The global control programs of the Club of Rome closely parallel the policies of various other elite "think tank" organizations pushing for a "One-World Government". One of these groups, the Council on Foreign Relations located in New York, has been covertly directing American economic/political policies since the early 1900s.* The genocide/depopulation programs outlined in this report are only a small, but devastating part of "new international order" plans set in motion long ago. The common link to these "new order" organizations has been traced by many theorists to the Order of the Illuminati.....

The Illuminati is a One-World Government organization founded by a sadistic Jesuit priest, Adam Wieshaupt in 1776. "Illuminati" literally means "illuminated ones" or "enlightened ones", as the members believe they are the only ones enlightened enough to rule the world. Briefly explained, the Illuminativists have since spread out over the world, gone underground, and now direct the activities of front organizations promoting international economic reforms, international control over agriculture and land, technology, medicine, and numerous social/political aspects of the global community. Yet they receive little or no mass publicity because of the very secret nature of their work, and because of the power they hold over the media.

At least one individual has come "out of the closet" to explain the Illuminati's connection to modern-day One-World organizations. His name is Stan Deyo, a computer specialist turned lecturer from Australia who once worked with one of the Illuminati fronts on mind control tests, anti-gravity research, and "new economic order" technology.** Stan's research covers 6 main Illuminati fronts (see chart at right) but the most revealing information on world management is explained through his research on the Club of Rome.....

As mentioned, the C of R (like the other Illuminati tentacles) is composed of the very rich and the political elite scattered throughout various government posts, corporation management positions, and research institutions. Most of the Club's "solutions" to the total disaster they predict

for the world are derived from computer research. According to the 1972 Club report, "Limits to Growth", their computer model "simulates the major ecological forces at work in the world today." Their computers also tell Club administrators not only the need for population reduction, control of the finances of the world, redistribution of food and energy resources, etc., but also how to carry out these changes in the most effective, albeit merciless, manner possible. Of course, computers have no conscience nor any sense of human rights and freedoms, thus if genocide is the most effective way to deal with overpopulation, then genocide will be recommended by C or R computers! The same can be said of a One-World Government system.

Some of the projections given by the Club's computers over a decade ago have turned into chilling realities--including the Reagan Administration's "economy recovery" plans to redistribute the wealth/resources from the poor/middle class to the affluent. 'Limits to Growth' also spells out the "need" for sacrifices made by the poor in order to attain "global equilibrium". This includes not only economic sacrifices, but sacrifices of health and human lives as well in an effort to rid the world of the poverty-stricken masses referred to by the Club of Rome advocates as "useless eaters".

REPLACING OUR PRESENT CONSTITUTION

As stated, the Club of Rome has much in common with the other Illuminati factions, and is one of the co-sponsors of a "Declaration of INTERdependence", part of a new "World Constitution" which was signed by 106 congressmen and 24 senators on July 4, 1976.* This "declaration" is in reality a document of treason intended to replace our U.S. Constitution and all other constitutions/governments of the world. The "Declaration of INTERdependence" calls for global regulation of nature, including:

Economic "collaborative regulation by international authorities";

International communal use and regulation of the seas, flora and fauna, mineral resources, "common property", and even the health of mankind;

Regulation of the "exploration and utilization of outer space";

The setting up of a "World Court" headed by "the United Nations and its specialized agencies." (Emphases added, but quotes are from the actual wording of the "declaration".)

Nowhere in this new "declaration" is it spelled out that the global managers to head the One-World Government "guidelines" are to be elected by the masses they will control. It is rather obvious that the advocates of "INTERdependence" intend for the global managers to be appointed by the Illuminati factions pushing for implementation of this new declaration--two of which are the Council on Foreign Relations and, of course, the Club of Rome. Some of the other organizations supporting the "Declaration of INTERdependence" include:

the Aspen Institute for Humanistic Studies; the Center for Strategic and International Studies; the U.S. Council of the International Chamber of Commerce; the Brookings Institute; the Rockefeller Foundation; American Society of International Law; Philadelphia Girl Scouts (a Rockefeller institution); the American Bar Association; Space Center-General Electric Co.; Harvard Divinity School, and dozens of other "peace" organizations—all promoting a World Government and, in turn, unwitting contributors to the Global 2000 genocide program.

"INTERDEPENDENCE" UNCONSTITUTIONAL

The ultimate controls granted the One-Worlders under the described "Declaration" have already been set up in the U.S. under Pres. Nixon's 1969 Executive Order #11490, an Order updated by his successors. This presidential directive, along with other Executive Orders, would give the current president and his appointed administrators certain controls over the nation—controls which over-ride Congress's constitutional authority. These combined Executive Orders would give the president and his staff what would amount to dictatorial control over nearly every aspect of American life; these are to be implemented in the event of a "national emergency", which does not necessarily mean anything as drastic as a nuclear war. The controls described would include: the takeover of communications; food/gas (and other energy) distribution and rationing; takeover of private industry and private property/land; the creation of 10 regions or "newstates" (referred to as "regionalism"), as well as many others. The "newstates" have already been implemented, will replace our constitutional 50 states and merely await an "emergency" to happen before the full takeover begins. The Executive Orders completely over-ride our U.S. Constitution, an act which is, of course, unconstitutional and treasonous! Congress cannot even review the president's executive take-over for 6 months according to these Orders. Even a new money system—complete with a brand-new currency—has been set up awaiting the day the president calls a "national emergency".*



Thus you can see that the "interdependence" theme (which amounts to non-electoral dictatorship) is nothing new, but has been attempted throughout recent history. Similar proposals have been initiated to varying degrees by all of the Illuminati fronts (see diagram on p. 3; the Trilateral Commission and Bilderberger groups are Rockefeller institutions.) The Club of Rome, however, appears to be the implementor of the genocide/depopulation programs—the other Illuminati factions carry out other One-World goals.....

YET ANOTHER "NEW CONSTITUTION"

In 1964 the Rockefellers (who had been running America since John D.) created a constitution to replace our present one, through the tax-exempt Center for the Study of Democratic Institutions (CSDI) in Santa Barbara, California. This new secret constitution will also restructure our electoral system, restricting citizens' voting and other rights and limiting the power of our elected representatives. It was designed to give the PEOPLE as little freedom as possible, while our MOB RULERS are free to mold new laws however and whenever they see fit.** In 1974, a final version of the "Newstates of America Con-

stitution" was published in the book 'The Emerging Constitution', by the CSDI's Rexford G. Tugwell (published by Harper & Row, \$20). This "Newstates Constitution" is intended to allow the Rockefeller powers to retain complete control over the American people through the following dictatorial changes:

The RIGHT TO BEAR ARMS is limited to the police, the armed forces, and only those specified by the NEW GOVERNMENT (Article I, Section 8);

Our constitutional 50 States will merge into larger NEWSTATES SUBSERVIENT TO THE NEW GOVERNMENT as designated by the APPOINTED BOUNDARY COMMISSION (Art. II, Sec. 1);

The president will APPOINT NEW GOVERNORS FOR EACH NEWSTATE, and the BOUNDARY COMMISSION shall have jurisdiction OVER EACH NEWSTATE (Art. XII, Sec. 6, 7, 8);

NEW LAWS will be written and enforced by a JUDICIAL ASSEMBLY, headed by an APPOINTED PRINCIPLE JUSTICE (Art. VIII, Sec. 1, 2);

ALL LARGE CORPORATIONS/INDUSTRIES WILL BE CHARTERED AND REGULATED by a NATIONAL REGULATORY BOARD, carried out by an APPOINTED INVESTIGATION AND ENFORCEMENT AGENCY (Art. VII, Sec. 3);

The LEGISLATIVE SENATE will be composed of GOVERNORS AND OTHER APPOINTED OFFICIALS, who will serve a LIFE TERM (Art. VI, Sec. 1, 2);

A NATIONAL WATCHKEEPER, appointed by the Senate, will take over many of the duties which are now performed by our present Senate (Art. VI, Sec. 11);

The PRESIDENT, succeeded by TWO VICE PRESIDENTS, WILL SERVE A 9-YEAR TERM (Art. V, Sec. 1);

An OVERSEER OF THE ELECTORAL BRANCH, appointed by the Senate, will NOMINATE (APPOINT) CANDIDATES FOR THE PRESIDENT/VICE PRESIDENT, and only then will a national election take place (Art. III, Sec. 8);

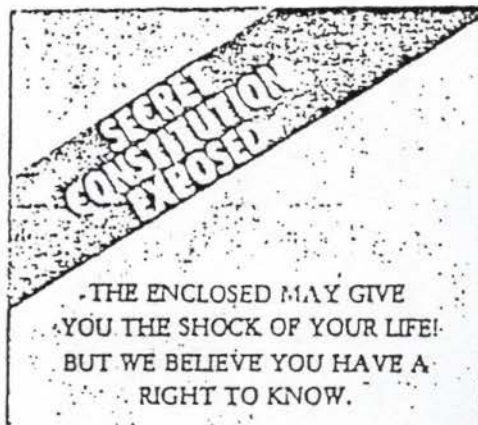
A NATIONAL PLANNING BRANCH, APPOINTED BY THE PRESIDENT, will regulate the NATIONAL BUDGET (Art. IV, Sec. 1, 2);

An APPOINTED CHANCELLOR OF FINANCIAL AFFAIRS, answerable to one of the Vice Presidents, will REGULATE ALL FINANCIAL AND MONETARY SYSTEMS OF THE NATION, also SUPERVISING the House of Representative's authority to coin/regulate money (Art. V, Sec. 8).....

...And that's only the beginning!; Under Article I ("Rights and Responsibilities") of this Newstates Constitution, many of the "rights" described include an escape clause, nullifying that particular "right" under a "declared emergency". The president also has the authority to over-ride most of the other Articles by "Executive Order"—he can raise taxes, remove officials from office, and manipulate laws by declaring an "emergency". In fact, the Newstates Constitution is so loosely written--it expires 25 years after its enactment--that in most instances the president has the final dictatorial power. The entire Newstates Constitution could easily replace our U.S. Constitution this year, because as of this writing (June 1982) only 3 more states are needed to endorse a constitutional convention, allowing our representatives to replace or throw out entire sections of our present Constitution if they so desire. We (the citizens) will have no say in these procedures.....

iving under the thumb of the Illuminati faction's "One-World Government". The following section will reveal 2 very important and dangerous proposals now pending through legislation that will bring us all closer to One-World rule, whereas genocide is legalized.....

Genocide/Atlantic Union Treaties

GENOCIDE TREATY TO SET UP "WORLD COURT"

says 'The SPOTLIGHT' (3/22/82), world government advocates have attempted again to push their policies through a law such as the ratification of the Genocide Treaty. Such a treaty "would not prevent genocide as its proponents claim but would take away our national sovereignty and change the meaning of international law, among other things, Americans could be tried overseas by an international court (emphasis added)," states 'SPOTLIGHT'.

This treaty--which the U.S. would be bound to if ever enacted by legislation--would, for instance, make it an international crime to speak against Israel (or any other race or nationality) since such an act could be construed as "mental genocide" according to the loosely-written wording of the treaty. Although we are assured by certain representatives, like Sen. William Proxmire, that the treaty would prevent genocide, it would in fact deter freedom of speech in America and would also make entire groups of people here accountable to a "World Court", over-riding our Constitution's guarantee to trial by jury and give this "World Court" the authority even to execute the accused group if it so desired! The Genocide Treaty would have absolutely no effect on war-monger nations or military terrorists since war and military groups are exempt from the treaty! The treaty would only leave Americans wide open for abuse.

Genocide Treaty advocates have been trying to have it ratified for some 33 years but are currently meeting opposition by constituents, however, readers of this booklet are encouraged to write your representatives opposing ratification, as the Genocide Treaty is still before hearings in the Senate.

'The SPOTLIGHT' has also reported on another measure--ignored by the rest of the media--which endangers our sovereignty and economic independence. It is the Atlantic Union Convention (Treaty), which, says 'SPOTLIGHT', "would make the U.S. party to a federal Atlantic Union composed of NATO countries, which would all surrender significant national sovereignty to an international economic commission (emphasis added)." The A.U.C. treaty is being explained as a measure for "strengthening of NATO alliance to make it more effective in containing communism," but this is simply a lie! These same NATO nations also control the International Monetary Fund--a worldwide "central bank" working toward the implementation of a "New Economic Order" as described earlier in this booklet. This brings us to one of the largest, legitimized organizations advocating "One-World Government" ever accepted by the world: the United Nations.....

Mass Murder Policies of the '80s

U.N. AMBASSADOR ADVOCATES GENOCIDE

According to 'New Solidarity' newspaper* (2/12/81), genocide policies similar to those of the Club of Rome are now advocated by the United Nations through the U.S.'s ambassador, Jeanne Kirkpatrick, who resigned her post with the "Committee for the Free World" to impose genocide policies world-wide. Says 'New Solidarity', the Committee is composed

of "the same group of Social Democrats and European feudalists who created...international terrorism in the 1970s (and) has come together...to bring about world war, global depopulation, and cultural devastation in the 1980s," and is also expected to aid Al Haig in building war fever against the Soviet Union. The 'Solidarity' article states that Kirkpatrick, through the UN, hopes "to confront Third World countries" because the "prime intent of the Committee will be to eliminate the problems in U.S. relations with the developing sector by eliminating the developing sector (emphasis added)." Kirkpatrick's UN support of Israel's terrorist activities speaks for itself.

On Febr. 10, 1981 the Committee held a press conference in New York and one in London. One of the speakers was director of the (Jewish) Anti-Defamation League, who told listeners that Israel "must be turned loose as a marcherlord to crush the Arab oil-producing countries"—a plan which U.S. administrations have been secretly advocating since the early '70s!

The following are some of the 400 Committee for the Free World members noted for their pro-stance on war and genocide: * Roger Starr, N.Y. 'Times' editor who advocates tuberculosis as a means to reduce poor in U.S. cities; * Robert Moss, British intelligence coordinator of the black propaganda that the Soviets control world terrorism; * Bernard Lewis, British-trained Islamic and author of a scheme to balkanize/feudalize Middle East; * Michael Novak, Jesuit-trained ideologue assisting Kirkpatrick from his post on the UN Human Rights Commission; * Lord Chalfont, British propagandist for early thermonuclear war with Soviet Union; * Sidney Hook, member American Humanist Assoc., whose magazine advocates the widespread use of euthanasia and the end of the sovereign nation-state.

GLOBAL 2000 AS "NATIONAL SECURITY": EL SALVADOR

As mentioned previously, the current Global 2000 genocide policies of our government stem from the "Global 2000" report written for Pres. Carter on the effects of pollution and overpopulation. Since Kissinger's attempt to sell Global 2000 depopulation as "national security", numerous bills have been introduced into legislation geared to control or eliminate various population sectors throughout the world. One of these is the "Population Policy Act of 1991" (H.R. 907) submitted by Rep. Richard Ottinger (D-N.Y.). Similar bills are being pushed through Congress by persons like Mike Kitch of the Zero Population Growth organization, all with little or no news coverage. 'Solidarity' also links the environmental group "Committee for the Year 2000" with implementing the Global 2000 depopulation doctrine. Reagan Administration policies consistently encompass genocide in one form or another, particularly by financing dictatorships that slaughter their own citizens and those of neighboring countries. (The U.S. remains the largest arms supplier to foreign countries in the entire world!) "National security" serves only to cloud the REAL issue of global genocide.....

According to the 3/10/81 edition of 'New Solidarity', Global 2000 groups have adopted a strategy of " 'managed' starvation, disease, and drought, in combination with programmed 'little wars' and planned social chaos." Last year the Center for Strategic and International Studies held a seminar to study the population of El Salvador as well as genocide "solutions" to reduce El Salvador's population by millions. Featured speakers at the seminar included William Faddock, former State Dept. advisor, and the CGIS's George Fauriol. Faddock's "solution" to El Salvador was to (quote) "let it bleed, let

"the people die," supported by Fauriol's opinion that there are "three million or so too many people in El Salvador" who must be eliminated. Paddock has further stated that Mexico needs to reduce its population by 48 million and that the U.S. should reduce our population to 100 million! (Remember, these people are our nation's policy makers and DO indeed have the finances and backing to support the policies they make!)*

Reagan announced he would "support"--meaning with arms and military backing--whoever won the Salvadoran elections held earlier this year, leading one to believe the "winner" was selected long BEFORE the elections. (Also bear in mind that it is the general population--civilians--being killed in the "crossfire" between the Salvadoran dictatorship government and "leftist guerrillas". Evidence given in Part II of the "Global 2000" series will show how CIA-sponsored military governments in Central America have formed "death squads" to torture and kill the citizenry!)

U.S. SUPPORTS WAR/TERRORISM THROUGHOUT THE WORLD

According to a local radio report (KFMQ, Lincoln) given in March, Reagan has asked Congress to approve a \$25 billion "defense" spending spree just for foreign military aid and arms!...and that figure is expected to rise to \$30 billion, TWICE the amount spent just 4 years ago. Also, according to the report, the U.S. is the major arms peddler to 28 of 41 military dictatorships that practice "torture, indiscriminate arrest and execution." By 1985 our federal government--with the approval of Congress--expects to spend 1 1/2 TRILLION tax dollars on "defense". Reagan has already shown where those tax dollars will come from as America continues to plunge into a depression.

Birth & Death Control the Global 2000 Way

STERILIZATION, DISEASE, WAR, ETC. AS POPULATION CONTROL

The 9/8/81 edition of the 'Christian Science Monitor' reports Sen. ports 'Solidarity' (9/11/81). Taylor is also the enforcer of the Vietnam war, which was actually aimed at reducing Vietnam's population (which it did), and he is believed to be using the same depopulation tactics today through the Pentagon. According to Taylor's own words: "I have already written off more than a billion people...in Africa, Asia, Latin America...These people will suffer from continuous cycles of natural disasters, famine, hunger, flood, drought..."

Last year it was reported in 'New Solidarity' that Sweden has begun practicing sterilization of female citizens as a birth control measure. In Sept. of 1981 alone at least 23 Swedish women died as a direct result of sterilization surgery, with even more suspected deaths. The program is conducted by the Swedish International Development Agency which STILL considers the program a "success"! SIDA officials even went to the Cancun North-South summit last October to sell the sterilization plan to Third World leaders....

POT POL & U.N. ADVOCATE "CHINA MODEL" FOR GENOCIDE

Just before the Cancun conference, the Mexican Senate denounced Haig's plan to deploy the neutron bomb, as well as denouncing the propaganda that a nuclear war could be "limited". Also before the summit, Mexico's President Jose Portillo revealed his concerns to Pres. Reagan on the plan for the U.S. to send troops to El Salvador, possibly turning that country into another Vietnam. The Mexico City 'Universal' newspaper called Washington's policies "(an) attempt to impose greater geo-political control (of the world by) systematic genocide."

In mid-Sept., during the first day of the General Assembly of the UN, participating countries voted 77 to 37 to keep the seat of Kampuchea (a Chinese country) in the hands of the ousted Pol Pot regime, all with "full knowledge...that under pol Pot's regime, with full complicity of Peking (1975-79) some 3 million out of the country's 8 million people were murdered in labor camps (emphasis added)," reports a 9/22/81 'New Solidarity'. The article also reported the Pol Pot genocide as a "China model" of "forced sterilization and labor-intensive ruralism," adding that Haig blackmailed dissenting nations into voting for the Pol Pot post by threatening to cut off World Bank/International Monetary Fund finances.

The Pol Pot genocide plans are based on a British-authored "Brandt Commission Report" calling for the elimination of "useless eaters". The Pol Pot vote was called by the Vietnam ambassador to the UN as "an encouragement to those who carried out the worst violations of human rights that has ever been committed." Interestingly, the U.S.S.R., its satellites and India were of the minority to oppose the Pol Pot seat at the UN.

China is considered by the Global 2000 factions as a "problem area" of overpopulation, thus, according to a 3/27/82 KFMQ radio report, the UN has decided to conduct a massive "Chinese census" covering every square mile of China and its provinces. The UN—considered by Stan Deyo and other "conspiracy theorists" as an arm of the Illuminati—will be using 21 computers supplied by the UN with the main goal of showing China's need for extensive population reduction. The article on the next page (from the 7/23/81 Washington 'Post') reveals how communist officials have dealt with overpopulation since last year—which also includes "severe economic penalties" for couples bearing more than one child.* So far the "controlled breeding" laws are a failure, thus the

PEKING—Arguments have begun to surface in the official Communist Party newspaper that propose controlled breeding of Chinese people through laws prohibiting those with genetic defects, including color blindness, from marrying or having children.

On June 8, the People's Daily published an article by a medical officer in Liaoning Province who said: "We have done very little to improve the quality of the population."

He said "necessary laws" are required to keep those with "congenital diseases" from producing children.

CATHOLIC CHURCH A THREAT

In an 7/28/81 interview with 'Executive Intelligence Review' magazine* Dr. Stephen Mumford of the International Fertility Research Institute cited the Roman Catholic Church as the single largest threat to the Global 2000 depopulation efforts--a threat which they intend to "confront". 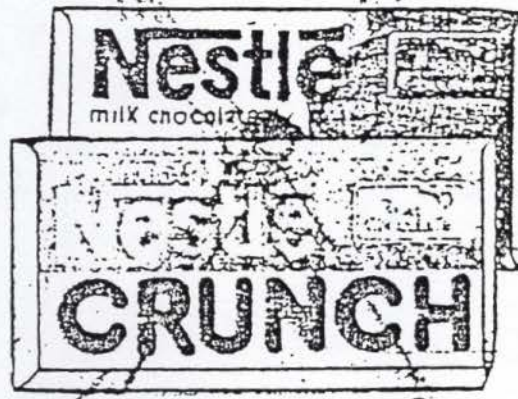

most of whom cannot even read the instructions and warnings given with the formula. Another major problem Nestle is fully aware of is sanitation, because the water used with the formula is usually unfit for babies to drink; plus Third World mothers fail to clean the bottles properly. Added to this, the formula is too expensive for poor mothers to afford, thus they try to stretch a small weekly supply among their large families over a period of months. The babies slowly die of starvation; the mothers have little choice but to keep buying the formula, because (as most mothers know) once they discontinue breast-feeding for a week or so, the mother's breast milk dries up! One of the most unethical practices of Nestle is to give "free" samples to doctors and midwives (Nestle representatives) who administer the formula to the mothers --not unlike the way pushers give "free" samples of heroine to naive school kids and then charge high prices for the stuff after they become addicted! The "free" formula, once the mother's milk dries up, thus becomes a necessity to keep the babies alive.

Slow Death by Pollution

ROCKEFELLER'S PRIVATE MEDICAL CABAL: THE A.M.A. & F.D.A.

Few people realize that the American Medical Association (AMA) of today is actually a joint brainchild of John D. Rockefeller and Andrew Carnegie in an effort to corner the health market in America and stamp out any kind of health care which could not be profitable for them. According to Dr. High Drummond, writing for 'Mother Jones' magazine* (July 1980), the AMA was taken over in 1910 by these billionaires who then implemented the "Flexner Report", requiring extensive medical schooling, the exclusive use of drugs and surgery in treating the ill, and mandatory licensing of doctors through state licensing boards. This effectively drove herbalists, midwives and homeopaths out of business, as well as any other alternative health care not "approved" by the AMA and FDA cabal. The medical scam in America reaches far and wide and includes the National Cancer Institute, the American Cancer Society, and many other government subsidized medical establishments that rake in the money and administer expensive "treatment" but have yet to find any cure for cancer, heart disease, arthritis or any other expensive illness.* This is why medical textbooks are written by pharmaceutical companies; why the FDA allows flouride (also used as a rat poison) into our water systems and other cancer-causing agents into our food and environment, while banning treatments like Laetrile, Vitamin therapy, many herbs, etc.; this is why they have OKed over 610 useless drugs not only proven ineffective, but which carry harmful side-effects.** This is the "pay as you die" program that has evolved because of the stranglehold of the AMA/FDA cabal that regulates our lives and deaths. This Profit-through-Death tactic is also effectively used by industry with full compliance of the FDA and AMA....

THE POLLUTION "SOLUTION" TO OVERCROWDING

The 'National Health Federation'*** (6/80) printed an article titled "Elitists See Pollution as Population Control Tactic" which offers evidence that pollution is purposely being used to curb population growth. During the Kennedy Administration, a secret research group reportedly held think tank meetings in a shelter below Iron Mountain in New York, as headed by Dr. Herman Kahn (another of the Vietnam perpetrators). A portion of the study's findings reads as follows: "Poisoning of the air, , and of the principle sources of food and water supply is already well advanced, and would seem to be promising in this respect. However, it will be a generation to a generation-and-a-half before pollution can offer a basis for a solution."

The preceding report is referring to nuclear power pollution, but applies just as well

many other kinds of pollution, such as acid rain caused by sulfur gasses given off during the burning of coal (a phenomenon killing plant/animal life in hundreds of lakes and streams in the U.S. alone!)

In the case of nuclear radiation—krypton and tritium—98.5% of these pollutants are "global travelers" and fall outside of the countries producing this form of energy. THE RAPE OF MOTHER EARTH CONTINUES

Man-made pollutants are causing what is called the "Greenhouse Effect", whereby a build-up of carbon dioxide takes place along with other non-breathable particles suspended in the air. Short-wave radiation passes through this carbon dioxide and causes heat to be trapped in Earth's atmosphere. As a result, we have smog, destruction of the thin ozone layer (which protects our breathable atmosphere), and disturbances in natural weather patterns. The Greenhouse Effect is caused by a combination of automobile exhaust, coal/oil burning factory exhaust, and other fossil fuel pollutants. (One renewable source of energy, alcohol fuel, produces no measurable pollutants and can be distilled at half the cost of petroleum fuel, as well as producing a by-product which can be fed to livestock when grain is used to make it, yet it has been conveniently quashed by past and present administrations and the oil cartel as a reliable source of energy.*)

The warnings of scientists on the Greenhouse Effect have been ignored for nearly 20 years. More recently, the Clean Air Act and the Clean Water Act have been adopted, but according to an April 8, 1982 New York 'Times' article, the Reagan Administration has proposed to drop the rule of mandatory treatment of toxic wastes before dumping them in municipal sewage systems, a change in the Clean Water Act which will make this law worthless and perhaps bring on more catastrophes like the Love Canal atrocity! In an RKO radio report given in March '82 it was revealed how legal bribes are used by large corporations to bypass environmental laws altogether. According to Common Cause, a citizens' lobby, 93 industries which violate the Clean Air Act have contributed 3/4 of a million dollars in re-election funds for our legislatures; the Clean Air Act expires this year.

Another "watchdog" group, Environmental Action, issued a "Filthy Five" award this April to the following companies for outstanding, repeated violations of environmental laws, as well as for being "heavy contributors to congressmen with poor environmental voting records": Dow Chemical Co., Standard Oil of Indiana, Occidental Petroleum Co., Republic Steel Corp., and the Weyerhaeuser Corp. (which is the chief abuser, with 941 notices of air/water violations and overharvesting of forests in 1981 alone!) It is far cheaper to bribe congressmen and pay fines than to adhere to even the laxest clean air and water standards. Unfortunately it is you and I who ultimately pay, through diseases, cancer, birth defects and even sterility by drinking poison water and breathing poison air.

DEFORESTATION THREATENS ATMOSPHERE

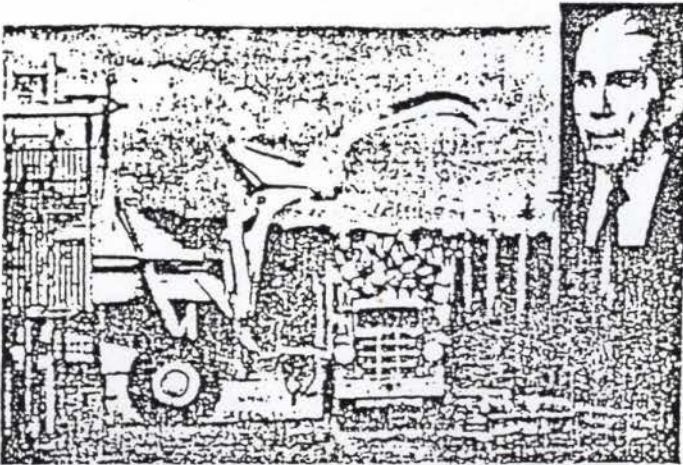
Without the large forests on this planet. (such as in Africa, Brazil, N. America) life as we know it would not exist. These forests provide oxygen to the atmosphere, help clean the air, and provide food & shelter for wildlife. A recent issue of 'Science Digest' cites the case of Easter Island as an example of what could happen should the deforestation of our planet continue on its present course. As reported, Easter Island—now barren and desolate—once held a sizeable population with plenty of trees and food sources. However, in only a few centuries the natives used up all edible vegetation and eventually chopped down every tree on the island for heat. Thus having no way to build boats to escape the island, the last few survivors were forced to practice cannibalism!—all because they became greedy and did not practice replenishing methods. The same thing is happening today!.....

'Science Digest' also reported on many of the Southern Hemisphere countries which are

suffering the same pollution problems as northern countries because of primitive "slash-and-burn" land clearing methods used to grow food crops. Says 'Science Digest': "Thousands of acres go up in smoke each year in South America, Africa, India and Asia to provide new land for planting crops...in the Brazilian rain forest alone, an area the size of Connecticut is annually put to the torch." To add to the problem of air pollution, if the mat of decayed plants, microbes and roots is scraped away from the charred surface of these rain forests, new plants will not grow and rain will wash away the fertile soil leaving a barren desert. (Bear in mind that much of this land is owned by foreign interests, not struggling families, and is usually used to grow export produce.)

Also according to 'Science Digest' (Jan. '82) U.S. forests are vanishing as well. Ninety-three percent of Illinois' forests, for example, are owned by citizens who are cutting them down because farmers don't get "price supports" from the government for forest land, a problem in many states these days.

LUDWIG'S DEFORESTATION PLANS THWARTED

Fifteen years ago, an American billionaire, Daniel Ludwig (see photo) bought up 6,000 square miles of dense rain forest in the Amazon. He paid only \$3 million for the land according to the 1/25/82 issue of 'Time' magazine, and began to clear the land. But his "jungle crusher" caterpillars damaged the valuable topsoil. Because of this and "pesky government regulations and xenophobic attitudes" of the Amazon people, Ludwig abandoned the money-making venture. Also, the Brazilian government refused to finance his project further. (This is how billionaires and millionaires make and keep their huge sums—by looking to governments, via tax money

for their profitable projects. The history of the Rockefellers is yet another example.) Ludwig defaulted on his loans for the project, \$413 million worth, and the land will be sold to Brazilian banks, insurance companies and other industries. But Ludwig just happens to have investments in a Switzerland-based cancer "research" center, which 27 Brazilian companies will pay dividends to for the next 35 years—all with the backing of the government to bring in even more funds.

HAMMER GRABS THE CANCER PROFITS

Another billionaire to jump on the solid gold cancer train is Armand Hammer, head of Occidental Petroleum and owner of the Hooker Chemical Co., which was responsible for the cancer-poisoning of Love Canal residents and other toxic waste disasters. Pres. Reagan has appointed Hammer to head the President's Cancer Panel, according to 'Mother Jones' (Jan. '82). When asked if he felt hypocritical about his acquisition of Hooker Chemical—which faces a \$200 million lawsuit by New York state—Hammer called the dumping of toxic wastes in Love Canal a "legal method of disposal", something he "inherited".

In 1976 Hammer was fined \$3000 for illegally contributing \$54,000 to Richard Nixon's 1972 campaign. Now, according to 'The SPOTLIGHT' (4/12/82) Hammer has just invested \$230 million in a coal mining deal with Red China, which will produce one of

the world's largest mines (not to mention acid rain and "black lung"). Hammer will soon be raking in \$600 million a year from the deal. He is known to have "intimate" dealings with the Soviets, yet he doesn't believe the Red China deal will conflict with his lucrative Soviet business ventures. Explains Hammer: "There's no problem. The Chinese are communists, you know. And they are well aware of how much I helped Nikolai Lenin and the Boshevik Revolution."

POLLUTION THAT CAUSES STERILITY

As previously mentioned, various types of pollution can and DO make individuals sterile and can cause birth defects, at least according to the July '80 and April '82 issues of 'Mother Jones' (see article below). Reportedly, "American men's sperm counts (have) declined drastically over the past 50 years,"

Call Off Your Copters

It's like an eye for an eye. Only worse: Demonstrators who were occupying land targeted to be sprayed with herbicides near Medford, Oregon, report that they were doused with the chemicals this spring when the Bureau of Land Management (BLM) decided to spray despite the protest.

At least eight members of the Applegate Occupation Team claim they were hit with the herbicide 2,4-D, a component of Agent Orange which may cause birth defects and other health problems.

About 15 minutes before the aerial spraying, officials used a loudspeaker to warn that those who did not leave

the site would be arrested. Protesters say they responded with hoots and whistles, indicating they would stay.

A BLM spokesperson claims the demonstrators "packed up and left" the thick brush prior to the spraying.

While the chemical may have occupiers down, it hasn't knocked them out: during a series of negotiations following the incident the BLM agreed—at least for this season—not to spray some of the sites that were occupied. Hardy Applegates have pledged not to be content with winning one battle, but to work for a complete moratorium on the use of 2,4-D in their state.

which has been traced to the following 4 toxic chemicals, according to tests conducted by Florida State University in 1979: DDT; polychlorinated biphenyls (PCBs); Hexachlorobenzene, and; pentachlorophenol—substances used every day, across the nation. They are all known carcinogens and teratogens (causing birth defects). Of the 132 students tested, ALL had "alarmingly high levels" of these chemicals in their systems, with 30 (almost 1/4) of the subjects rated as effectively sterile as a direct result of the toxicity levels found. Ironically, the students tested were healthy young men who lived in non-industrial areas. Yet SOMEHOW these chemicals ended up in their bodies!

The list given of probable "genotoxins" (substances which lower the fertility rate in both men and women) include: herbicides, pesticides, industrial chemicals of all kinds, tobacco, marijuana, antibiotics, diethylstilbestrol (DES),

lead, X-rays, and even some forms of artificial light and video display terminals! Some of these genotoxic herbicides/pesticides have been banned by the EPA, yet they are still showing up in our food and drinking water! Another toxic herbicide, dioxin (an ingredient in Agent Orange) is considered one of the most toxic substances on Earth, but it is STILL being used in the U.S. at the rate of 2 million pounds a year, and is used even more in other countries; Oregon women near spray areas were found to show a high rate of miscarriage.

The article covered many more substances that are making us sterile (including precription drugs, covered in another report) and also gave tips on how to "protect your fertility", such as: wash fruit/vegetables with soap; drink distilled or bottled spring water frequently; use a reliable filter for tap water; take vitamin C; avoid taking drugs, smoking and X-rays; lobby for the ban on toxic sprays. Although it cannot be said for sure that the Global 2000 groups are purposely using these chemicals to sterilize America and other countries using them, it can be said that little is being done to correct this atrocity. Your legislators need to hear from you on these vital issues!
