

STATEMENTS AND FACTS THAT CAN BE USED ON A WATER FLUORIDATION - LEGAL NOTICE OF NON-CONSENT

[While the following is designed for central Ohioans, it can be easily modified for other areas by personalizing the items displayed in grey.]

As a flesh and blood woman whose water supply is purchased from the CITY OF COLUMBUS - the only source available for my home at 125 Maple Place, Columbus, Ohio - I declare the following:

- 1) I am aware that in 1969 the LEGISLATIVE OFFICE OF THE STATE OF OHIO passed a statute requiring fluoridation of public water supplies that serve more than 5,000 persons.
- 2) I am aware that the private trade organization known as the AMERICAN DENTAL ASSOCIATION recommends water fluoridation.
- 3) I am aware the CENTER FOR DISEASE CONTROL (CDC) and the HEALTH, OHIO DEPARTMENT OF recommend water fluoridation.
- 4) I am aware of many scientific peer-reviewed papers that have exposed the health dangers of ingesting fluoridated water and that in 2000 the EPA's union of scientists and others recommended that water fluoridation be stopped due to its detrimental effect on human health.
- 5) I am aware that eminent toxicologists have exposed that the chemicals currently used to fluoridate water are NOT pharmaceutical grade but are silicofluorides (industrial waste labeled *poison*) which is why the OHIO ENVIRONMENTAL PROTECTION AGENCY (EPA) is obligated to set a maximum allowable "containment" level.
- 6) I am aware that the LEGISLATIVE OFFICE OF THE STATE OF OHIO had no toxicology or medical training and were unduly influenced by lobbyists and/or the CDC. I do not accept their corporate statutory mandates as science-based.
- 7) I do not recognize the AMERICAN DENTAL ASSOCIATION as a professional health advocacy organization. It is a private corporation listed on Dun and Bradstreet and headquartered in the STATE OF ILLINOIS that represents the monetary interests of practicing dentists and claims no responsibility or liability for injuries (to include fluorsis) or illnesses created by the toxic effects of the chemicals dumped into public water systems in the name of "water fluoridation".
- 8) I do not recognize the CDC as a government health advocacy organization. It is a private corporation listed on Dun and Bradstreet and headquartered in the STATE OF GEORGIA. Therefore, their recommendations are influenced by the 'fiscal' health of their corporation. And, I am aware that Dr David Lewis, a former CDC scientist and author of the book *Science for Sale*, has documented extensive scientific fraud in their reports.
- 9) I do not recognize the HEALTH, OHIO DEPARTMENT OF as a government health advocacy organization. It is a private corporation headquartered in COLUMBUS OH and listed on Dun and Bradstreet. Their recommendations are influenced by the 'fiscal' health of their corporation.
- 10) I am unaware of any code or regulation that specifically authorizes utility service providers to add toxic industrial waste chemicals, known to harm flesh and blood men, women and children, into their water supply without "full disclosure and written consent". My water bill does not disclose that industrial toxic waste (labeled as *poison*) is intentionally disposed of in the public water supply that is then piped into my home. If such a statute exists, please send me the name, number and effective date.

11) I am unaware of any contract I have signed specifically agreeing to allow water laden with toxic industrial waste chemicals piped into my home. If you have such a contract in your possession, please forward a copy to me.

12) I am aware that enforcement of STATE OF OHIO corporate statutes - without full disclosure and written consent - lack "mutuality" and are therefore null and void. This also applies to the legislated "mandate" regarding the fluoridation of my household water supply.

13) To the best of my knowledge Mayor Coleman and CITY OF COLUMBUS council members: Andrew J. Ginther, Hearcel F. Craig, Zachary M. Klein, A. Troy Miller, Michelle M. Mills, Eileen Y. Paley, Priscilla R. Tyson have no lawful authority to harm my health or the health of my family members - without my consent.

For the reasons I have listed and more, as a flesh and blood woman, **I do not consent to having the water piped into my home - that I am compelled to purchase from your company - contaminated with silicofluorides (or similar chemicals) in the name of water fluoridation.**

Cease and desist adding silicofluorides (labeled *poison*) to the water I purchase from your company or provide me with another source - for the same price - that does not contain silicofluorides or similar chemicals added for the purpose of water fluoridation.

Should Mayor Coleman and CITY OF COLUMBUS council members: Andrew J. Ginther, Hearcel F. Craig, Zachary M. Klein, A. Troy Miller, Michelle M. Mills, Eileen Y. Paley, and Priscilla R. Tyson refuse to cease and desist from adding silicofluorides to the water that comes into my home, I will use all lawful and legal remedies to hold these individuals personally - and in their official capacity - liable for any and all harm caused by their unlawful act of poisoning my water supply.

NOTE: This denial of consent document can be used to protect Mayor Coleman and CITY OF COLUMBUS council members: Andrew J. Ginther, Hearcel F. Craig, Zachary M. Klein, A. Troy Miller, Michelle M. Mills, Eileen Y. Paley, Priscilla R. Tyson from any punitive statutory actions or penalties generated by corporate agencies or corporate state governments should the above wisely decide to stop adding silicofluorides (or similar chemicals for the purpose of water fluoridation) to the public water supply I am compelled to buy.
