CEASE & DESIST: Town Orders Family to Stop Hosting Bible Studies on Farm

The owners of a Pennsylvania farm have been ordered by the Sewickley Heights Borough to cease and desist holding Bible studies on their private property.

Borough leaders accused Scott and Terri Fetterolf of improperly using their 35-acre farm as a place of worship, a place of assembly and as a commercial venue.

They were served a cease-and-desist order in October 2017, the Post-Gazette reported.

The Independence Law Center filed a federal lawsuit on behalf of the farmers against the borough alleging an egregious violation of the U.S. Constitution.

According to the lawsuit, the Fetterolfs were threatened with fines of \$500 per day plus court costs for having Bible studies at their home, having meetings where religious songs are sung, conducting any religious retreats for church leaders or seminary students or conducting any religious fundraisers.

"The borough has no business overseeing a group of people reading and discussing a book together on private property – even if that book is the Bible," attorney Randall Wenger said in a statement.

The lawsuit accuses the government leaders of violating religious freedom, freedom of speech, freedom of assembly and equal protection.

"Government should not target religious activities for punishment, particularly when similar secular activities are permitted," attorney Jeremy Samek said. "In America, no government can categorically ban people from assembling to worship on one's property."

To that point, the lawsuit alleges the borough allows other activities and gatherings - ranging from political rallies to a Harry Potter event.

So if government leaders allow muggles to cavort in Sewickley Heights Borough, they should afford the same rights to Christians gathering for Bible study on private property.

Liberals force Conservative Churches to host Gay 'Marriage'



"Episcopal dioceses in the United States which reject the notion of same-sex 'marriage' must now allow gay and lesbian couples to 'marry' in the church," [reports](#) LifeSiteNews.

"The Episcopal Church's General Convention meeting in Austin, Texas last week found a way to expand gay 'marriage' rights into all dioceses while seemingly respecting the consciences of local bishops who object on theological grounds.

"Praised as a compromise that doesn't alienate traditionalists, the resolution essentially allows an end-run maneuver around the consciences of the leaders of eight U.S. dioceses who are standing firm against same-sex 'marriage.'

"Beginning in December, when a gay couple wants to 'marry' in a diocese where the same-sex 'marriage' is not condoned, the priest who has agreed to conduct the ceremony will be free to bypass his or her bishop and reach out to an Episcopal bishop elsewhere who can step in and provide 'pastoral support' for the mono-gendered couple.

"Not all bishops were enthusiastic about the resolution. Some expressed grave concern that the move undermines their authority and could lead to a schism within the Episcopal Church.



"Bishop John Howard of Florida said his diocese was still reeling from the 2003 consecration of openly gay Bishop Gene Robinson, which led some clergy and lay members to break from the denomination, according to a report by RNS.

"Bishop William Love of Albany, New York used stronger language, saying, 'I'm concerned that when this passes, the floodgates are going to open once again, the bloodshed is going to open once again, the insidious lawsuits are going to continue once again.'"

Christian Judge suspended for Refusing Gay "Marriage"

"An evangelical judge who has refused to marry same-sex couples was handed down a three-year suspension without pay Thursday by the Oregon Supreme Court, the longest suspension in the court's history," reports Christian Post.

"Judge Vance Day, who was found to have broken several gun laws, and in 2014 refused to marry same-sex couples, will have 14 days to file a petition for the state Supreme Court to reconsider its decision.

"One of the main charges that Day was found guilty of concerned granting a gun to a felon who was on probation while Day served as judge at a special court for veterans.

"The court also ruled that Day had acted with prejudice against same-sex couples after he allegedly instructed staff at his office to say that he was unavailable for same-sex marriage requests, while heterosexual couples had their weddings scheduled...

"Our belief is he's being targeted for his Christian beliefs," said Ralph Spooner, one of Day's attorneys, on OPB.org.

Pastor faces Jail for Jesus in Canada

"A Christian bus driver in Toronto has been charged with a 'hate crime' for distributing pamphlets saying homosexuality can lead to diseases and that **Jesus can save gay people if they repent,**" [reports Christian Post](#).

Bill Whatcott "distributed anti-gay material which promoted hatred toward the gay community," Toronto Police Service said in a statement, adding that he was arrested in Calgary and later returned to Toronto.



The 51-year-old Christian man was charged with "willful promotion of hatred against an identifiable group, namely the gay community."

"The pamphlets he allegedly distributed said homosexuality is associated with sexually transmitted diseases, including HPV of the rectum, which the U.S. Centers for Disease Control says is true, according to The Federalist.

"The pamphlets, which reportedly **included negative remarks against the Liberal Party and left-wing politicians,** also said that supporting homosexual acts without repentance could lead to 'eternal peril,' and repentance to 'the free gift of eternal life.'

"However, reports say that the pamphlets neither encouraged hate against homosexuals, nor advocated violence.

"Whatcott, who has been fired from his job, said he wasn't given food for 24 hours while in jail, according to The Daily Wire.

"It might have been on purpose, because it didn't happen, like — some inmates did go half a day without food — but they actually made me go a full 24 hours," he was quoted as saying.

China blows up Megachurch

"Chinese authorities have demolished a well-known Christian megachurch, inflaming long-standing tensions between religious groups and the Communist Party," [reports](#) The Independent.

"Witnesses and overseas activists said the paramilitary People's Armed Police **used dynamite and excavators to destroy the Golden Lampstand Church**, which has a congregation of more than 50,000, in the city of Linfen in Shanxi province.

"ChinaAid, a US-based Christian advocacy group, said local authorities planted explosives in an underground worship hall to demolish the building following, constructed with nearly \$2.6m in contributions from local worshippers in one of China's poorest regions.

"The church had faced 'repeated persecution' by the Chinese government, said ChinaAid. Hundreds of police and hired thugs smashed the building and seized Bibles in an earlier crackdown in 2009 that ended with the arrest of church leaders.

"Those church leaders were given **prison sentences of up to seven years** for charges of illegally occupying farmland and disturbing traffic order, according to state media.

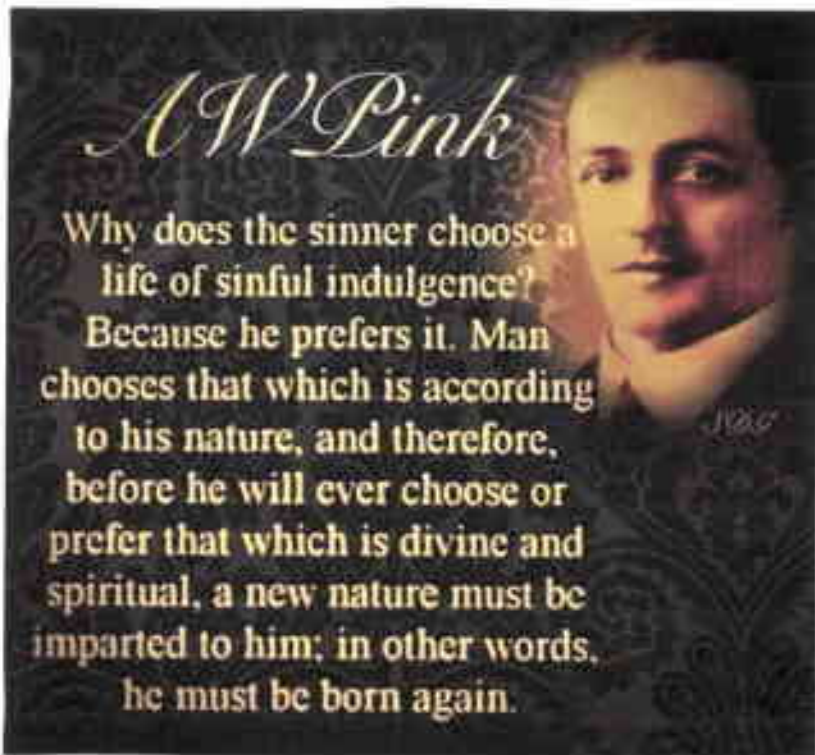
"There are an estimated 60 million Christians in China."

Christian goes to Prison for helping Child escape Lesbian

"It has a tug-of-war between Virginia and Vermont with Virginia finally giving jurisdiction to Vermont although Lisa was a Virginia resident, Isabella was born in Virginia, and Virginia had a Marriage Amendment on the books stating that only one man one woman marriages would be recognized in the Commonwealth of Virginia."

"There's no question, no doubt that Philip Zodhiates helped Lisa A. Miller [an ex-lesbian now born-again Christian mother] and her daughter make their way [from Virginia] to Buffalo, the first step in a journey that would catapult them into the national spotlight," [reports](#) The Buffalo News.

"But did the Virginia businessman do it because he wanted to keep the then-7-year-old Isabella R. Miller away from her 'other mother,' [the Lesbian stalker] or simply because he's a good man trying to do the right thing?"

"A jury found Zodhiates guilty of conspiracy and international kidnapping...."

"Miller and Jenkins separated in late 2003 [when Miller became a Christian] and eventually ended their lesbian civil union in Vermont. When Miller moved back to Virginia and tried to stop visits by Jenkins, the courts intervened and, at one point, appeared on the verge of transferring custody to Jenkins."

"Prosecutors say that's when Miller fled Virginia." [What Christian mother would not flee to protect their child from sexually perverse re-indoctrination?]

"Zodhiates, who will face prison time when he is sentenced by Arcara, was accused of helping Miller and her daughter make their way to Buffalo Niagara International Airport and later Toronto, where they caught a plane to Nicaragua..."

"Sometime in late September 2009, she and Isabella arrived in Managua, Nicaragua, and were greeted by Timothy D. Miller, a Mennonite pastor who is no relation to Lisa Miller."

"Recently arrested, Pastor Timothy Miller [pled guilty] in a Buffalo courtroom...and, like Zodhiates, [faced] conspiracy and kidnapping charges."

USAF General threatened with Prison for Praying

Fox News [reports](#) that Mikey Weinstein's Militant Religion Foes Foundation, MRFF is **"calling for the arrest of now Brig. Gen. Teichert – the new wing commander at Edwards Air Force Base in California," because he privately owns a web-site that encourages prayer.**

The MRFF is "an organization that trolls military bases in search of any public display of the Christian faith. The group is typically triggered by Nativity scenes and Bibles placed on Missing Man tables.

"Foundation founder Mikey Weinstein was especially angered to learn that Teichert owns a website called 'Prayer at Lunchtime for the United States.'

The website encourages "Bible-believing Americans to take time to specifically pray for our nation at lunchtime every day." It also features a prayer list – including among others President Trump, Vice President Mike Pence, Congress and the military.

Judge forces School Boys to shower with Girl

"The transgender agenda in public schools, which insists a person's sex is a subjective matter based on feelings, took a huge step forward this week with a federal judge ruling boys must be allowed to use girls' rest rooms and showers, and vice versa," [reports](#) WND.

"U.S. District Court Judge Marco Hernandez in Oregon did offer an alternative, however: **Parents who object to mixed-sex showers for their children can take them out of the schools** for which they pay...

"It is within Parent Plaintiffs' right to remove their children from Dallas [Oregon] High School if they disapprove of transgender student access to facilities," the judge said.

"Once the parents have chosen to send their children to school ... their liberty interest in their children's education is severely diminished."

"His ruling, however, conflicts with President Trump's rescinding of an Obama administration guidance letter directing schools that want to continue to receive federal funding to let transgender students use facilities that correspond with their 'gender identity'....



"The judge defined 'sex' as 'processes that lead to or denote male or female.' He said such a characteristic is 'assigned' at birth, but 'gender' is a person's 'subjective, deep-core sense of self as being a particular gender.'

"A 'transgender boy' is therefore a person who has a lasting, persistent male gender identity, though that person's sex was determined to be female at birth," he said.

"In the Dallas [Oregon] district, an unidentified female student submitted such a claim to be a boy, and the school developed a plan to allow her to use the boys' facilities.

"The parents then objected."

[Pastor faces Eviction for holding Bible Studies in Apartment](#)

"A semi-retired Lutheran pastor and his wife allegedly have been ordered by their residential complex to stop holding Bible studies in their private apartment — or face eviction," [reports](#) The Blaze.

"Why? Apparently the apartment complex defines 'Bible study' as a 'business' — and one that's prohibited from taking place in private residential units.

"The Christian law firm, First Liberty, is representing Ken and Liv Hauge, who reside at the Evergreens at Smith Run, a senior living community in Fredericksburg, Virginia.

"First Liberty provided on its website a redacted letter to the attorney for the complex's management company, challenging the claims against the couple and demanding the powers-that-be stop actions against the Hauges.

"The firm also posted what it said is a redacted 'formal notice' to the couple, threatening them with eviction over the Bible studies.

The letter "not only says the Hauges can't hold Bible studies in the community room any longer, but also it prohibits Bible studies they might want to hold in their private apartment, as the Bible studies are considered 'business' operations. The letter also states that Hauges must vacate their residence by Aug. 31 unless they agree to comply.



"The Hauges — both of whom are in their mid-80s — agreed to stop leading the Bible studies until the matter is resolved, First Liberty said "

Transgenders force Boy Scouts name change to "Scouts"

"We wanted to land on something that evokes the past but also conveys the inclusive nature of the program going forward," said Chief Scout Executive Mike Surbaugh. "We're trying to find the right way to say we're here for **both young men and young women.**"



"The parent organization will remain the Boy Scouts of America, and the Cub Scouts

— its program for 7- to 10-year-olds — will keep its title as well.

"But the **Boy Scouts — the program for 11- to 17-year-olds — will now be Scouts BSA.**

"The organization has already started admitting girls into the Cub Scouts, and Scouts BSA begins accepting girls next year.

"Surbaugh predicted that both boys and girls in Scouts BSA would refer to themselves simply as scouts, rather than adding 'boy' or 'girl' as a modifier."

CNN reported In 2017, "The Boy Scouts of America said it will begin accepting members based on their gender identity, opening the door for transgender boys to join. Under the new policy, which takes effect immediately, membership in Cub Scouts and Boy Scouts will be based on the gender indicated on an application."

In 2015 "The Boys Scouts of America...lifted the ban on gay adults as Scout leaders. And [in 2014] it allowed allowed openly gay youths to join scouting," [reported](#) CNN.

[California Senate advances Bible Ban, Christian Therapy Ban](#)

"Canada's highest court has affirmed a legal right for a secular organization to deny entry to a Christian institution on the basis of its moral requirements," reports WND.com

"The Supreme Court of Canada, in a pair of 7-2 rulings, found Friday that the law societies of British Columbia and Ontario can refuse accreditation to Trinity Western University's proposed law school because of its so-called community covenant.

"As a Christian institution, Trinity Western requires students and faculty to abide by biblical boundaries on sexual behavior. The covenant also requires students to abstain from, among other things, obscene language, harassment, lying, stealing, pornography and drunkenness.

“The progressive press won't touch it, the regular press doesn't seem to follow these issues, and self-publishing a story like this would likely have been pointless,” Chart told *The Post*. “And I know most of the audience of a publication like *The Christian Post* might not sympathize with my political views, but I would rather hope that everyone reading would look beyond me, and to the institutional rot of a political edifice that was so easily taken over by a sex industry advocacy that's alien to its founding principles.”

Mainstream liberal feminist is diametrically opposed to freedom of thought

What's interesting about the whole thing is that, despite all the rhetoric about giving the marginalized a “voice,” the feminists and liberals working within the confines of organizations that are pushing for the legalization of child sex work are prohibited from using theirs.

Chart says that she came to realize that not only was she prohibited in her former job from speaking her own opinions on the matter, but so were her colleagues. Those who hold “unpopular opinions” in opposition to child sex trafficking are routinely marginalized and muzzled, similar to what she experienced as a former Jehovah's Witness.

“There was this really intense policing about who you are allowed to talk to, who you are allowed to know,” Chart says about what goes on in some of the more mainstream feminist circles, “whose arguments you are allowed to respond to, who is allowed to quote whom. It was a disturbing sort of social experiment.”

After repeated attempts to try to reason with both her colleagues and superiors, Chart learned that there simply isn't room for free thinking in these liberal feminist echo chambers, especially when it comes to opposing anti-women movements [like transgenderism](#). Everyone is expected to fall in line or else leave, which is ultimately what drove Chart to seek refuge in telling her story at *The Post*.

Police issue Canada-wide arrest warrant for Christian accused of LGBT 'hate' crimes

TORONTO, June 20, 2018 ([LifeSiteNews](#)) – Toronto police have issued a Canada-wide warrant on charges of inciting hatred for a Christian who handed out flyers at the 2016 Toronto Pride Parade warning of the spiritual and biological dangers of sodomy.

Bill Whatcott announced on the [Free North America](#) portal he intends to turn himself in to the Calgary police on Friday, June 22 at 10:00 a.m.

Toronto 51 Division is charging Whatcott with the indictable offence of inciting hatred under Section 391 of Canada’s Criminal Code.

“The ‘crime’? My ministry bringing the Gospel and the truth about homosexuality to Toronto’s homosexual pride parade in 2016,” Whatcott wrote on Free North **America.**

Constable Caroline de Kloet, media relations officer for Toronto Police Service, said the charges arose from a two-year investigation into a complaint the police received in 2016, but that police don’t give out “victim information.”

The Toronto police were in contact the federal attorney general on the case, as is the procedure with hate crimes, she told LifeSiteNews. “It’s not something we lay on a regular basis.”

Whatcott registered in the 2016 Pride parade under the pseudonym Robert Clinton on behalf of the [Gay Zombies Cannabis Consumers Association](#).

Dressed in skin-tight green bodysuits with face masks, Whatcott and five others marched in the parade and handed out 3,000 packages on “Zombie Safe Sex” that included a flyer entitled: “We want you to practice safe sex.”



The two-page pamphlet featured graphic images of anal warts, a mottled corpse described as an “AIDS fatality,” and one of “genital warts in the mouth,” beside a headshot of Prime Minister Justin Trudeau.

It excoriated the “homosexual activism” of Trudeau, former Liberal defence minister Bill Graham, and now-outgoing Ontario Premier Kathleen Wynne, and blasted Wynne’s sex-ed curriculum and its connection to former deputy minister of education Ben Levin, convicted in 2015 of three child pornography charges.

“Canada has embarked on a destructive journey toward sexual anarchy and homosexual inspired oppression,” the pamphlet declared.

“The clear evidence contained in this package shows Canada’s new sexual ethic is contrary to natural law and no good will come of it.”

A month after 2016 Toronto Pride Parade, activist lawyer Douglas Elliott launched a [\\$104 million class action suit](#) against Whatcott and the five unnamed “zombies,” and anyone who aided and abetted them.

“We are going to go after everyone who helped him,” Elliott said at a press [conference](#). “Every person, every church, every non-profit organization, everyone who helped this wicked man promote his hatred is going to be held accountable.”

That was echoed by the suit’s two named plaintiffs -- former Liberal MPP and openly homosexual George Smitherman, and homosexual bar owner Christopher Hudspeth.

Hudspeth said the lawsuit would “smoke out” all those who helped Whatcott, and Smitherman said he was “pleased” to “do all we can to stamp this hateful individual out.”

The lawsuit claimed Whatcott’s actions defamed and caused pain to the some 9,000 recipients of the leaflets, 500,000 estimated watchers of the parade, and a subclass of individuals publicly identified as Liberals.

Elliott alleged the 2016 leaflet was similar to four pamphlets critical of homosexuality Whatcott handed out in Saskatchewan in 2000 and 2001. The Supreme Court ruled in 2013 that two of these were [hate literature](#).

Whatcott’s lawyer, Charles Lugosi, argued the lawsuit was an attack on Charter freedoms of speech, thought, expression, religion, and association.

Justice Paul Perell ruled in March 2017 that Elliott could not claim defamation of an entire group, such as the Pride Parade participants or the “LGTBTQ2SI Community,” but only of individuals.

But he also issued an order that Whatcott disclose the names his fellow half “gay zombies” as well as those of “unidentified financial backers” who funded the group’s expenses.

The judge ruled knowing these identities was necessary for the homosexual advocates if they decide to go ahead with further legal action.

Lugosi told LifeSiteNews both parties are appealing Perell’s ruling. The disclosure order against Whatcott will not be enforced during that process.

Meanwhile, the newly formed Canada Anti-Hate Network (CAN) described the criminal hate charges against Whatcott as “welcome” news.

Whatcott “has been a leading figure in the dissemination of homophobic hate propaganda in Canada for years,” CAN’s chair Bernie Farber said in a Monday [press release](#).



But Canadians should be alarmed at the state’s prosecution of Whatcott for “distributing gospel pamphlets,” says Calgary-based Pastor Art Pawlowski, founder of Street Church, and a friend of Whatcott.

“We’re turning Canada into a Nazi state, into a communist state, where if you voice your politically incorrect views, you will be attacked by the forces of the government,” Pawlowski told LifeSiteNews.

He’s organizing a rally in front of the Calgary Police headquarters, 5111 47 St. N.E. Calgary, for June 22 at 10:00 am, when Whatcott plans to turn himself in.

After his arrest, Toronto Police will fly out to take Whatcott to Toronto to answer to the charges in court, and for a bail hearing, Constable De Kloet told LifeSiteNews.

“It’s our responsibility because it’s our warrant to go and pick them up,” she said. “It’s a lot of work, it involves a flight usually...you maybe need a hotel, you’ve got to fly with your gun. It’s very expensive.”

Whatcott echoed this.

“This one’s kind of a shock,” he told LifeSiteNews. “I used to be a real criminal...I know if you knock off a liquor store with a knife, it’s highly unlikely they’d put out a Canada-wide, they’d probably put out a province-wide... they won’t spend the money to go after you.”

Whatcott, who raises [money online](#) for his legal battles, hopes he’ll get bail that allows him to return to Alberta, where he has a two-month-old job, and a wife and two children to support.

“One way I look at it is, for them to go this insane, that was obviously a really good flyer,” said Whatcott.

“I don’t think it’s going to go well,” he added. “But for me, it really is about following Christ.”

Terengganu, Malaysia *Righteous morality in a heathen norm*
Lesbians caned: Two gay Malaysian women found guilty of attempting to have sex were caned in a sharia law court this week in front of some 100 people—the first such punishment conducted in public. Sharia law enforcement officers in the conservative state of Terengganu said they caught the women—ages 22 and 32—in a parked car in April; they were sentenced to a fine and six lashes each. Malaysia has a two-track justice system, and the nearly two-thirds of its 31 million people who are Muslim are governed by Islamic courts in family, marriage, and personal issues. Homosexuality is illegal under both secular and Islamic laws, and in 2017, two gay men were lashed 83 times each for having sex. “This case shows a regression for human rights,” said Thilaga Sulathireh of the Malaysian rights group Justice for Sisters. “Not only for LGBT people, but all persons.”

China's 'Digital' Totalitarian Experiment

The question now is whether the increasingly defiant Chinese people will accept President Xi's all-encompassing vision.

By 2020, Chinese officials plan to have about [626 million surveillance cameras](#) operating throughout the country. **Those cameras will, among other things, feed information into a national "social credit system."**

That system, when it is in place in perhaps two years, will **assign to every person in China a constantly updated score based on observed behaviors**. For example, an instance of jaywalking, caught by one of those cameras, will result in a reduction in score.

Although officials might hope to reduce jaywalking, **they seem to have far more sinister ambitions**, such as ensuring conformity to Communist Party political demands. In short, the government looks as if it is determined to create what the *Economist* called "[the world's first digital totalitarian state](#)."

China's President Xi Jinping is not merely an authoritarian leader. He evidently believes the Party must have absolute control over society and he must have absolute control over the Party. He is taking China back to totalitarianism as he seeks Mao-like control over all aspects of society. (Photo by Lintao Zhang/Getty Images)

That social credit system, once perfected, will surely be extended to foreign companies and individuals.

At present, there are more than a dozen national blacklists, and about three dozen various localities have been operating experimental social credit scoring systems. Some of those systems have failed miserably. Others, such as the one in Rongcheng in Shandong province, have been considered successful.

In the Rongcheng system, each resident starts with 1,000 points, and, based upon their changing score, are ranked from A+++ to D. **The system has affected behavior: incredibly for China, drivers stop for pedestrians at crosswalks.**

Drivers stop at crosswalks because residents in that city have, as *Foreign Policy* reported, "embraced" the social credit system. Some like the system so much that they have set up micro social credit systems in schools, hospitals, and neighborhoods. Social credit systems obviously answer a need for what people in other societies take for granted.

Yet, **can what works on a city level be extended across China?** As technology advances and data banks are added, the small experimental programs and the national lists will eventually be merged into one countrywide system. The government has already begun to roll out its "[Integrated Joint Operations Platform](#)," which aggregates data from various sources such as cameras, identification checks, and "wifi sniffers."

So, what will the end product look like? ***"It will not be a unified platform where one can type in his or her ID and get a single three-digit score that will decide their lives,"*** *Foreign Policy* says.

Despite the magazine's assurances, this type of system is precisely what Chinese officials say they want. After all, they tell us the purpose of the initiative is to ***"allow the trustworthy to roam everywhere under heaven while making it hard for the discredited to take a single step."***

That description is not an exaggeration. Officials prevented [Liu Liu](#), a journalist, from taking a flight because he had a low score. The *Global Times*, a tabloid that belongs to the Communist Party-owned *People's Daily*, reported that, as of the end of April 2018, authorities had blocked individuals from taking 11.14 million flights and 4.25 million high-speed rail trips.

Chinese officials, however, are using the lists for determining more than just access to planes and trains. ***"I can't buy property. My child can't go to a private school,"*** Liu said. ***"You feel you're being controlled by the list all the time."***

The system is designed to control conduct by **giving the ruling Communist Party the ability to administer punishments and hand out rewards.** And the system could end up being unforgiving. Hou Yunchun, a former deputy director of the State Council's development research center, said at a forum in Beijing in May that the social credit system should be administered so that "discredited people become bankrupt".

"If we don't increase the cost of being discredited, we are encouraging discredited people to keep at it," Hou said. ***"That destroys the whole standard."***

Not every official has such a vindictive attitude, but it appears that all share the assumption, as the dovish Zhi Zhenfeng of the Chinese Academy of Social Sciences said, that "discredited people deserve legal consequences."

President Xi Jinping, the final and perhaps only arbiter in China, has made it clear how he feels about the availability of second chances. "Once untrustworthy, always restricted," the Chinese ruler says.

What happens, then, to a country where only the compliant are allowed to board a plane or be rewarded with discounts for government services? No one quite knows because never before has a government had the ability to constantly assess everyone and then enforce its will. The People's Republic has been more meticulous in keeping files and ranking residents than previous Chinese governments, and computing power and artificial intelligence are now giving China's officials extraordinary capabilities.

Beijing is almost certain to extend the social credit system, which has roots in attempts to control domestic enterprises, to foreign companies. Let us remember that Chinese leaders this year have taken on the world's travel industry by forcing hotel chains and airlines to show Taiwan as part of the People's Republic of China, so they have demonstrated determination to intimidate and punish. Once the social credit system is up and running, it would be a small step to include non-Chinese into that system, extending Xi's tech-fueled totalitarianism to the entire world.

The dominant narrative in the world's liberal democracies is that tech favors totalitarianism. It is certainly true that, unrestrained by privacy concerns, hardline regimes are better able to collect, analyze, and use data, which could provide a decisive edge in applying artificial intelligence. A democratic government may be able to compile a no-fly list, but none could ever come close to implementing Xi Jinping's vision of a social credit system.

Chinese leaders have long been obsessed with what then-President Jiang Zemin in 1995 [called](#) "informatization, automation, and intelligentization," and they are only getting started. Given the capabilities they are amassing, they could, the argument goes, make defiance virtually impossible.

Technology might even make liberal democracy and free-markets "obsolete" [writes](#) Yuval Noah Harari of the Hebrew University of Jerusalem in the *Atlantic*. "The main handicap of authoritarian regimes in the 20th century — the desire to concentrate all information and power in one place — may become their decisive advantage in the 21st century," he writes.

There is no question that technology empowers China's one-party state to repress people effectively. Exhibit A for this proposition is, of course, the country's social credit system.

Yet China's communists will probably overreach. The country's experience so far with social credit systems suggests that officials are their own worst enemies. An early experiment to build such a system in Suining county in Jiangsu province was a [failure](#):

"Both residents and state media [blasted](#) it for its seemingly unfair and arbitrary criteria, with one state-run newspaper comparing the system to the 'good citizen' certificates issued by Japan during its wartime occupation of China."

The Rongcheng system has been more successful because its scope has been relatively modest.

Xi Jinping will not be as restrained as Rongcheng's officials. He evidently believes the Party must have [absolute control](#) over society and he must have absolute control over the Party. It is simply inconceivable that he will not include in the national social credit system, when it is stitched together, political criteria. Already Chinese officials are trying to use artificial intelligence to predict anti-Party behavior.

Xi Jinping is not merely an authoritarian leader, as it is often said. He is taking China back to totalitarianism as he seeks Mao-like control over all aspects of society.

The question now is whether the increasingly defiant Chinese people will accept Xi's all-encompassing vision. In recent months, many have taken to the streets: truck drivers striking over costs and fees, army veterans marching for pensions, investors blocking government offices to get money back from fraudsters, Muslims surrounding mosques to stop demolition, and parents protesting the scourge of adulterated vaccines, among others. Chinese leaders obviously think their social credit system will stop these and other expressions of discontent.

Military and U.S. Law Enforcement Establishing Joint Communication Network for Biometric Databases

Does anyone remember that it used to be considered a conspiracy theory to warn people about biometric databases? Well, now that it is an accepted reality, we should be looking even farther down the slippery slope for new signposts indicating even greater plans to track, trace and database all human beings.

Apparently it is neither sufficient — nor *efficient* — to have the myriad databases currently at the disposal of agencies like the Department of Defense, FBI or Homeland Security. According to a release from [Biometric Update](#), these agencies currently use different computer languages that have difficulty communicating with each other as seamlessly as the U.S. government desires.

The U.S. Defense Department, the FBI, and the Department of Homeland Security are planning to establish a new standard in 2019 to allow their biometric databases to communicate seamlessly, DoD officials told an audience at the AFCEA (Armed Forces Communications and Electronics Association) Federal Identity Forum in Tampa, Florida, [SIGNAL](#) reports.

The Electronic Biometric Transmission Specification (EBTS) version 4.1 will enable the DoD's ABIS, DHS's IDENT, and the FBI's NGI (next generation identification) system to communicate natively, "in their own language," according to DoD biometrics program chief engineer Will Graves. DHS is preparing to upgrade from its IDENT system to the new Homeland Advanced Recognition Technology (HART) in order to handle scale and capabilities far beyond those it was [originally designed for](#).

"Hopefully we'll be able to close the transactional and interoperability gap between DOD and DHS," he says.

Perhaps most notable is the apparent conflation of military systems and U.S. national justice systems into one overall sharing network. While the military is supposed to be restrained by [Posse Comitatus](#) from showing up on American soil to police the public, things appear to be more malleable where data collection systems are concerned.

The FBI is already mired in controversy for its role in attempting to suppress information about the domestic NGI database cited in the quote above. *Activist Post* reported about this massive database that contains fingerprints, palm prints, iris, voice, and face scans, as well as other biometric data of millions of non-criminal Americans.

Bottom of Form

As [Derrick Broze](#) wrote:

In early May the U.S. Department of Justice released a proposal which would exempt the FBI's biometric database from public disclosure. Specifically, [the proposal](#) would exempt the [Next Generation Identification \(NGI\) System](#) from provisions of the federal Privacy Act, which "requires federal agencies to share information about the records they collect with the individual subject of those records, allowing them to verify and correct them if needed." The proposal is open for public comment until June 6, 2016.

Although the database does contain biometric data on convicted criminals, it also contains information on individuals who were only suspected or temporarily detained under the suspicion of a crime. The system also features data from people fingerprinted for jobs, licenses, military or volunteer service, background checks, security clearances, and other government processes.

Essentially the FBI is arguing that it will prevent individuals from knowing if their information is in the massive database if the release of information would "compromise" a law enforcement investigation.



Jeramie Scott, a national security counsel at the Electronic Privacy Information Center, told NextGov that the proposal “would set a worrying precedent in which law enforcement has significant leeway to decide what information to collect without informing the subject.”

One can only assume that the military’s Automated Biometrics Identification System (ABIS) is even more immune from transparency. Nevertheless, this fact, in addition to the usual privacy and security concerns raised daily about what happens to our data after collection, also appears not to be an impediment as, “Modernizing the DoD’s biometric system, which is at least five years old, **may include moving the ABIS to the cloud.**” My emphasis added.

As I noted with the latest news that [India’s national biometric ID database was ruled constitutional](#) by its highest court, are Americans right to assume that its own constitutional protections will not be violated even as the evidence continues to mount that a similar system is being designed?

America moves closer to being a cashless society

If you want to buy a beer at Flatstick pub in Seattle, don’t whip out a \$10 bill to pay—you’ll walk away thirsty. Flatstick, a hot new mini-chain in the Pacific Northwest, doesn’t take cash. Neither does Bluestone Lane, a coffee chain with locations in New York, Philly and D.C. Patrons there have to pay with plastic or an app called LevelUp. Want to grab a Sweetgreen salad for lunch with cash? No can-do at many locations.

Cashless commerce is popping up around the country, particularly in restaurants catering to a younger crowd, which is likely to leave home without any greenbacks, or even a wallet, and instead choose to live life with a smartphone and a few credit or debit cards attached.

Businesses who’ve gone cashless rave about the results. Flatstick owner Sam Largent told me plastic-only reduces error rates during times of complex accounting, such as calculating tips when shifts change.

Cash sure seems to be on the ropes. The dollar value of cash transactions sank 7% from 2010 to 2015, according to The Nilson Report, while credit and debit card payments rose nearly 50%. Meanwhile, ATMs, which had their 50th birthday last year, are disappearing around the block and around the world, signaling the decline of the “cash run.”

Of course, cash-free environments aren't brand new. Airlines went cashless a long time ago (for meals and other onboard purchases), as did parking lots and other unmanned spots. And with the meteoric rise of friend-to-friend payment apps like Venmo, Zelle and Splitwise, we're no longer throwing \$20 bills on the table after a meal (or handing over cash or checks to roommates for the gas bill).

So you're saying cash is over?

Not exactly. The Federal Reserve said in 2016 that 35% of U.S. transactions were still made in cash. And the amount of cash—literally, legal tender notes—being used around the world continues to rise. Plus, there are still plenty of obstacles to going cashless.

For starters, the FDIC estimates that 7% of the U.S. population is still unbanked. In other words, they live an all-cash life, so would be entirely shut out in a cashless society. Some also like the anonymity that comes with paying cash. Others use cash for budgeting reasons (when you're out of cash, you stop spending).

Still, on a global scale, eliminating cash offers some intriguing possibilities. Merely the elimination of large denominations, which the EU has done, makes life much harder for large-enterprise criminals, like drug dealers. It's far more conspicuous to carry around large piles of small bills. If all financial transactions were electronic, hiding crime would become much more difficult. There's also the convenience factor of pulling out plastic (or your phone) instead of counting bills.

What does this all mean for law-abiding citizens like me?

Forces will undoubtedly continue nudging us toward a cashless life, which comes with plenty of benefits. Just remember that cashless spending is frictionless—it's just a swipe of a card or a wave of your phone. So, if you're already prone to overspending, get creative about curbing those tendencies and making sure your savings goals are on track.

LOS ANGELES — You will get chipped. It's just a matter of time.

In the aftermath of a Wisconsin firm embedding microchips in employees last week to ditch company badges and corporate logons, the Internet has entered into full-throated debate.

Religious activists are so appalled, they've been penning nasty 1-star reviews of the company, Three Square Market, on Google, Glassdoor and social media.

On the flip side, seemingly everyone else wants to know: Is this what real life is going to be like soon at work? Will I be chipped?

"It will happen to everybody," says Noelle Chesley, 49, associate professor of sociology at the University of Wisconsin-Milwaukee. "But not this year, and not in 2018. Maybe not my generation, but certainly that of my kids."

Gene Munster, an investor and analyst at Loup Ventures, is an advocate for augmented reality, virtual reality and other new technologies. He thinks embedded chips in human bodies is 50 years away. "In 10 years, Facebook, Google, Apple and Tesla will not have their employees chipped," he says. "You'll see some extreme forward-looking tech people adopting it, but not large companies."

The idea of being chipped has too "much negative connotation" today, but by 2067 "we will have been desensitized by the social stigma," Munster says.

For now, Three Square Market, or 32M, hasn't offered concrete benefits for getting chipped beyond badge and log-on stats. Munster says it was a "PR stunt" for the company to get attention to its product and it certainly succeeded, getting the small start-up air play on CBS, NBC and ABC, and generating headlines worldwide. The company, which sells corporate cafeteria kiosks designed to replace vending machines, would like the kiosks to handle cashless transactions.

This would go beyond paying with your smartphone. Instead, chipped customers would simply wave their hands in lieu of Apple Pay and other mobile-payment systems.

The benefits don't stop there. In the future, consumers could zip through airport scanners sans passport or drivers license; open doors; start cars; and operate home automation systems. All of it, if the technology pans out, with the simple wave of a hand.

Not a GPS tracker

The embedded chip is not a GPS tracker, which is what many critics initially feared. However, analysts believe future chips will track our every move.

For example, pets for years have been embedded with chips to store their name and owner contact. Indeed, 32M isn't the first company to embed chips in employees. In 2001, Applied Digital Solutions installed the "VeriChip" to access medical records but the company eventually changed hands and stopped selling the chip in 2010.

In Sweden, BioHax says nearly 3,000 customers have had its chip embedded to do many things, including ride the national rail system without having to show the conductor a ticket.

In the U.S., Dangerous Things, a Seattle-based firm, says it has sold "tens of thousands" of chips to consumers via its website. The chip and installation cost about \$200.

After years of being a subculture, "the time is now" for chips to be more commonly used, says Amal Graafstra, founder of Dangerous Things. "We're going to start to see chip implants get the same realm of acceptance as piercings and tattoos do now."

In other words, they'll be more visible, but not mainstream yet.

"It becomes part of you the way a cellphone does," Graafstra says. "You can never forget it, and you can't lose it. And you have the capability to communicate with machines in a way you couldn't before."

But after what we saw in Wisconsin last week, what's next for the U.S. workforce? A nation of workers chipping into their pods at Federal Express, General Electric, IBM, Microsoft and other top corporations?

Experts contend consumers will latch onto chips before companies do.

Chesley says corporations are slower to respond to massive change and that there will be an age issue. Younger employees will be more open to it, while older workers will balk. "Most employers who have inter-generational workforces might phase it in slowly," she says. "I can't imagine people my age and older being enthusiastic about having devices put into their bodies."

Adds Alec Levenson, a researcher at University of Southern California's Center for Effective Organizations, "The vast majority of people will not put up with this."

Three Square Market said the chips are voluntary, but Chesley says that if a company announces a plan to be chipped, the expectation is that you will get chipped — or risk losing out on advancement, raises and being a team player.

"That's what we're worried about," says Bryan Allen, chief of staff for state Rep. Tina Davis (D), who is introducing a bill in Pennsylvania to outlaw mandatory chip embedding. "If the tech is out there, what's to stop an employer from saying either you do this, or you can't work here anymore."

Several states have passed similar laws, while one state recently saw a similar bill die in committee. "I see this as a worker's rights issue," says Nevada state Sen. Becky Harris (R), who isn't giving up. "This is the wrong place to be moving," she says.

Should future corporations dive in to chipping their employees, they will have huge issues of "trust" to contend with, says Kent Grayson, a professor of marketing at the Kellogg School of Management at Northwestern University.

"You've got to have a lot of trust to put one of those in your body," Grayson says. Workers will need assurances the chip is healthy, can't be hacked, and its information is private, he says.

Meanwhile, religious advocates have taken to social media to express their displeasure about chipping, flooding 32M's Facebook page with comments like "boycott," "completely unnecessary" and "deplorable." On 32M's Google page, Amy Cosari a minister in Hager City, Wisc., urges employees to remove the chip.

"When Jesus was raised, he was raised body and soul, and it was him, not zombie, not a ghost and we are raised up in the same way," Cosari wrote. "Employees of 32Market, you are not a walking debit card."

Get used to it, counsels Chesley.

Ten years ago, employees didn't look at corporate e-mail over the weekend. Now they do, "whether we like it or not," he says.

Be it wearable technology or an embedded chip, the always on-always connected chip is going to be part of our lives, she says.

Intelligent Machines

This company embeds microchips in its employees, and they love it

Last August, 50 employees at Three Square Market got RFID chips in their hands. Now 80 have them.

When Patrick McMullan wants a Diet Dr Pepper while he's at work, he pays for it with a wave of his hand. McMullan has a microchip implanted between his thumb and forefinger, and the vending machine immediately deducts money from his account. At his office, he's one of dozens of employees who have been doing likewise for a year now.

McMullan is the president of Three Square Market, a technology company that provides self-service mini-markets to hospitals, hotels, and company break rooms. Last August, he became one of roughly 50 employees at its headquarters in River Falls, Wisconsin, who [volunteered to have a chip injected into their hand](#).

The idea came about in early 2017, he says, when he was on a business trip to Sweden—a country where [some people are getting subcutaneous microchips](#) to do things like enter secure buildings or book train tickets. It's one of very few places where chip implants, which have been around for [quite a while](#), have taken off in some fashion.

The chips he and his employees got are about the size of a very large grain of rice. They're intended to make it a little easier to do things like get into the office, log on to computers, and buy food and drinks in the company cafeteria. Like many RFID chips, they are passive—they don't have batteries, and instead get their power from an RFID reader when it requests data from the chip (McMullan's chip includes identifying information to grant him access to the building, as well as some basic medical information, for instance).

A year into their experiment, McMullan and a few employees say they are still using the chips regularly at work for all the activities they started out with last summer. Since then, an additional 30 employees have gotten the chips, which means that roughly 80 of the company's now 250 employees, or nearly a third, are walking, talking cyborgs.

"You get used to it; it's easy," McMullan says. As far as he knows, just two Three Square Market employees have had their chips removed—and that was when they left the company.

Sam Bengtson, a software engineer, says he uses his chip 10 to 15 times a day. At this point, swiping his hand over an RFID reader plugged into his computer is no different from typing in his password on a keyboard, he says.

Steve Kassekert, vice president of finance, is so used to using his hand to pay for soda at work that he was annoyed when the RFID reader on the vending machine went down a couple of months ago.

"It's just become such a part of my routine," he says.

The company is also exploring some ways to use microchips outside the body. McMullan says in August and September it is running tests at two hospitals—one in Fort Wayne, Indiana, and another in Hudson, Wisconsin—that will verify when doctors and nurses wash their hands. (They'll wear bracelets incorporating a chip that they can scan on an RFID reader to turn on a sink—something that [has been tried before](#).)

Nick Anderson, an associate professor in public health sciences at the University of California, Davis, says the privacy and security of any information stored on the chips is an obvious concern. The information gathered by readers could give lots of details about employees' comings and goings, and someone could in theory ping your chip with a reader to find out what's on it.

"You can sniff it if you're at a bus stop," he says.

McMullan says only some of the information stored on the chip in his hand is encrypted, but he argues that similar personal information could be stolen from his wallet, too.

There's also the chance—and it seems certain to happen eventually—that the technology inside the employees' bodies will become outdated. Bengtson, at least, is concerned about this.

"There may need to be a—dare I say—upgrade program, or something like that," he says.

Lawmaker Proposes Implanting Microchips in People to Track Non-Violent Offenders Like "Pets"

Toledo, Ohio – This Tuesday, Toledo City Councilman Rob Ludeman suggested that criminals be implanted with microchips so they can be tracked by police and the courts. Ludeman also made comments essentially describing people charged with crimes as animals.

The councilman said, “**this can’t be inhumane because we do it to our pets.**”

Ludeman suggested that implantable microchips should be used instead of ankle bracelets for people doing time on house arrest because ankle bracelets don’t work on the cop shows that he watches.

“I’ve seen enough shows on TV where the individual has slipped it off and they’ll go commit a crime and slip it back on. I can’t believe it’s an inhumane thing and I’ve got to believe the technology is there. We microchip our dogs, cats, there’s got to be a way that you can put a microchip in and it can’t be removed until their sentence is served or probation is over,” Ludeman said, according to the [Toledo Blade](#).

Luckily, other members of the city council did not immediately jump on board with the plan, but they weren’t extremely repulsed or offended by it either.

“It’s something I’d have to look into. We don’t want to be Big Brother. What we want to do is make sure people are where they say they’re going to be,” Councilman Gary Johnson said.

Councilman Nick Komives defended Ludeman, saying that he did not intend for his comments to be harmful. Komives went on to say that there are “probably” ethical problems with implanting microchips into prisoners and parolees.

“As a concept, I am not particularly in favor of microchipping human beings. We might find it humane for dogs because they run off, but I think there are probably a lot of moral and ethical questions that would come to mind when thinking of microchipping humans,” Komives said.

According to Deputy Court Administrator Burma Stewart, electronic monitoring is used on an increasing number of people, but the vast majority of them are non-violent offenders. Stewart also said that there have only been two attempted escapes in the past year and both of them were quickly apprehended.

Councilman Tom Waniewski seemed to be in favor of these types of measures to prevent drug dealers from making sales while on house arrest.

“They’re getting to the point where they are thumbing their noses at us. The police do too hard of a job to have them back in the community. It’s not fair to the residents. Boy, if there was a way that these ankle bracelets could do more than just monitor, I’d ask you to order a couple dozen more,” he said.

The fact that RFID chips have been known to [cause cancer](#) when implanted in humans was not brought up at the meeting.

[According to research](#) funded by the National Institute of Justice, prisoners who are released with electronic monitoring have a far lower recidivism rate than those who stay in jail for their full sentence.

There seems to be a fair amount of pushback that will hopefully prevent this from becoming a reality in Ohio anytime soon, but the fact that this even a conversation taking place at city council meetings is extremely alarming.

In 2004, the FDA approved the implantation of RFID microchips in humans, and while they are not widely used, there has been talk of them being used on soldiers, and one company in Wisconsin is forcing their employees to get chipped in order to access company computers and fulfill daily activities.

15 Health Problems Linked to Monsanto's Roundup

Monsanto invented the herbicide glyphosate and brought it to market under the trade name Roundup in 1974, after DDT was banned. But it wasn't until the late 1990s that the use of Roundup surged, thanks to Monsanto's ingenious marketing strategy. The strategy? Genetically engineer seeds to grow food crops that could tolerate high doses of Roundup. With the introduction of these new GE seeds, farmers could now easily control weeds on their corn, soy, cotton, canola, sugar beets and alfalfa crops—crops that thrived while the weeds around them were wiped out by Roundup.

Eager to sell more of its flagship herbicide, Monsanto also encouraged farmers to use Roundup as a desiccant, to dry out all of their crops so they could harvest them faster. So Roundup is now routinely sprayed directly on a host of non-GMO crops, including wheat, barley, oats, canola, flax, peas, lentils, soybeans, dry beans and sugar cane.

Between 1996 - 2011, the widespread use of Roundup Ready GMO crops increased herbicide use in the U.S. by 527 million pounds—even though Monsanto claimed its GMO crops would reduce pesticide and herbicide use.

Monsanto has falsified data on Roundup’s safety, and marketed it to parks departments and consumers as “environmentally friendly” and “biodegradable, to encourage its use it on roadsides, playgrounds, golf courses, schoolyards, lawns and home gardens. A French court ruled those marketing claims amounted to false advertising.

In the nearly 20 years of intensifying exposure, scientists have been documenting the health consequences of Roundup and glyphosate in our food, in the water we drink, in the air we breathe and where our children play.

They’ve found that people who are sick have higher levels of glyphosate in their bodies than healthy people.

They’ve also found the following health problems which they attribute to exposure to Roundup and/or glyphosate:

ADHD: In farming communities, there’s a strong correlation between Roundup exposure and attention deficit disorder (ADHD), likely due to glyphosate’s capacity to disrupt thyroid hormone functions.

Alzheimer’s disease: In the lab, Roundup causes the same type of oxidative stress and neural cell death observed in Alzheimer’s disease. And it affects CaMKII, an enzyme whose dysregulation has also been linked to the disease.

Anencephaly (birth defect): An investigation into neural tube defects among babies born to women living within 1,000 meters of pesticide applications showed an association for glyphosate with anencephaly, the absence of a major portion of the brain, skull and scalp that forms during embryonic development.

Autism: Glyphosate has a number of known biological effects that align with the known pathologies associated with autism. One of these parallels is the gut dysbiosis observed in autistic children and the toxicity of glyphosate to beneficial bacteria that suppress pathogenic bacteria, along with pathogenic bacteria’s high resistance to glyphosate. In addition, glyphosate’s capacity to promote aluminum accumulation in the brain may make it the principal cause of autism in the U.S.

Birth defects: Roundup and glyphosate can disrupt the Vitamin A (retinoic acid) signaling pathway, which is crucial for normal fetal development. The babies of women living within one kilometer of fields sprayed with glyphosate were more than twice as likely to have birth defects according to a study from Paraguay. Congenital defects quadrupled in the decade after Roundup Ready crops arrived in Chaco, a province in Argentina where glyphosate is used roughly eight to ten times more per acre than in the U.S. A study of one farming family in the U.S. documented elevated levels of glyphosate and birth defects in the children, including an imperforate anus, growth hormone deficiency, hypospadias (an abnormally placed urinary hole), a heart defect and a micro penis.

Brain cancer: In a study of children with brain cancer compared with healthy children, researchers found that if either parent had been exposed to Roundup during the two years before the child’s birth, the chances of the child developing brain cancer doubled.

Breast cancer: Glyphosate induces human breast cancer cells growth via estrogen receptors. The only long-term animal study of glyphosate exposure produced rats with mammary tumors and shortened life-spans.

Cancer: House-to-house surveys of 65,000 people in farming communities in Argentina where Roundup is used, known there as the fumigated towns, found cancer rates two to four times higher than the national average, with increases in breast, prostate and lung cancers. In a comparison of two villages, in the one where Roundup was sprayed, 31 percent of residents had a family member with cancer, while only 3 percent of residents in a ranching village without spraying had one. The high cancer rates among people exposed to Roundup likely stem from glyphosate's known capacity to induce DNA damage, which has been demonstrated in numerous lab tests.

Celiac disease and gluten intolerance: Fish exposed to glyphosate develop digestive problems that are reminiscent of celiac disease. There are parallels between the characteristics of celiac disease and the known effects of glyphosate. These include imbalances in gut bacteria, impairment in enzymes involved with detoxifying environmental toxins, mineral deficiencies and amino acid depletion.

Chronic kidney disease: Increases in the use of glyphosate may explain the recent surge in kidney failure among agricultural workers in Central America, Sri Lanka and India. Scientists have concluded, "Although glyphosate alone does not cause an epidemic of chronic kidney disease, it seems to have acquired the ability to destroy the renal tissues of thousands of farmers when it forms complexes with [hard water] and nephrotoxic metals."

Colitis: The toxicity of glyphosate to beneficial bacteria that suppress clostridia, along with clostridia's high resistance to glyphosate, could be a significant predisposing factor in the overgrowth of clostridia. Overgrowth of clostridia, specifically C. difficile, is a well-established causal factor in colitis.

Depression: Glyphosate disrupts chemical processes that impact the production of serotonin, an important neurotransmitter that regulates mood, appetite and sleep. Serotonin impairment has been linked to depression.

Diabetes: Low levels of testosterone are a risk factor for Type 2 diabetes. Rats fed environmentally relevant doses of Roundup over a period of 30 days spanning the onset of puberty had reduced testosterone production sufficient to alter testicular cell morphology and to delay the onset of puberty.

Heart disease: Glyphosate can disrupt the body's enzymes, causing lysosomal dysfunction, a major factor in cardiovascular disease and heart failure.

Hypothyroidism: House-to-house surveys of 65,000 people in farming communities in Argentina where Roundup is used, known there as the fumigated towns, found higher rates of hypothyroidism.

Inflammatory Bowl Disease (“Leaky Gut Syndrome”): Glyphosate can induce severe tryptophan deficiency, which can lead to an extreme inflammatory bowel disease that severely impairs the ability to absorb nutrients through the gut, due to inflammation, bleeding and diarrhea.

Liver disease: Very low doses of Roundup can disrupt human liver cell function, according to a 2009 study published in Toxicology.

Lou Gehrig’s Disease (ALS): Sulfate deficiency in the brain has been associated with Amyotrophic Lateral Sclerosis (ALS). Glyphosate disrupts sulfate transport from the gut to the liver, and may lead over time to severe sulfate deficiency throughout all the tissues, including the brain.

Multiple Sclerosis (MS): An increased incidence of inflammatory bowel disease (IBS) has been found in association with MS. Glyphosate may be a causal factor. The hypothesis is that glyphosate-induced IBS causes gut bacteria to leak into the vasculature, triggering an immune reaction and consequently an autoimmune disorder resulting in destruction of the myelin sheath.

Non-Hodgkin lymphoma: A systematic review and a series of meta-analyses of nearly three decades worth of epidemiologic research on the relationship between non-Hodgkin lymphoma (NHL) and occupational exposure to agricultural pesticides found that B cell lymphoma was positively associated with glyphosate.

Parkinson’s disease: The brain-damaging effects of herbicides have been recognized as the main environmental factor associated with neurodegenerative disorders, including Parkinson's disease. The onset of Parkinson’s following exposure to glyphosate has been well documented and lab studies show that glyphosate induces the cell death characteristic of the disease.

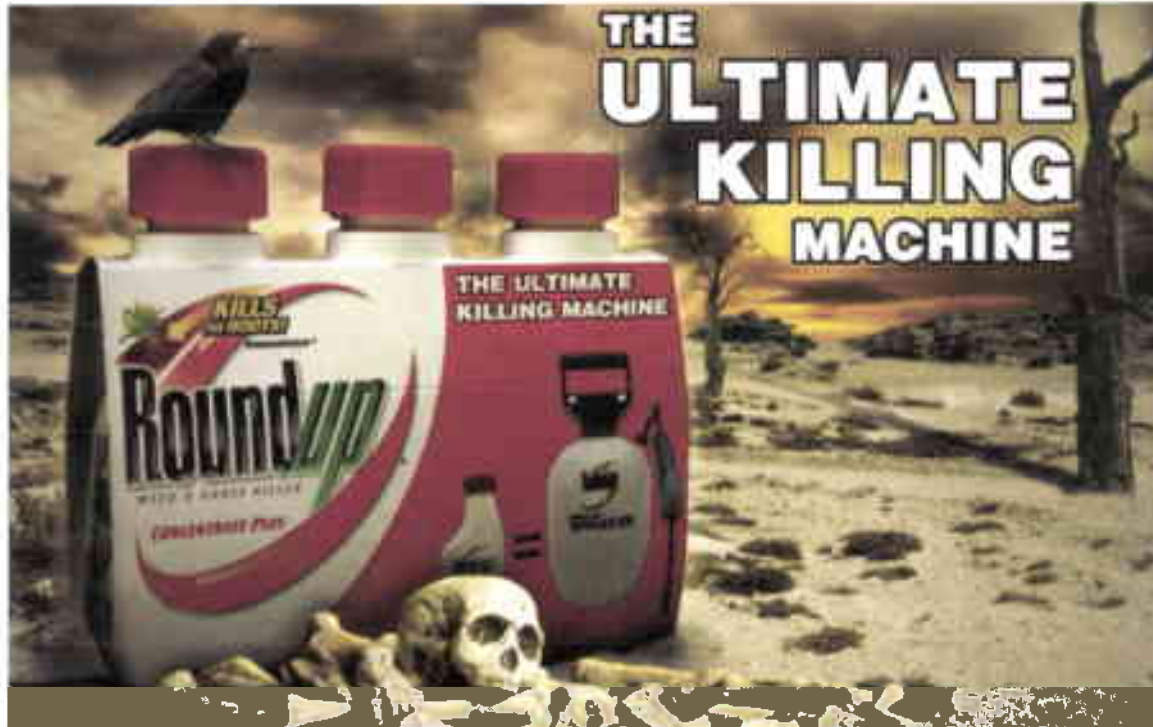
Pregnancy problems (infertility, miscarriages, stillbirths): Glyphosate is toxic to human placental cells, which, scientists say, explains the pregnancy problems of agricultural workers exposed to the herbicide.

15 Health Problems Linked to Monsanto's Roundup

Monsanto invented the herbicide glyphosate and brought it to market under the trade name Roundup in 1974, after DDT was banned. But it wasn't until the late 1990s that the use of Roundup surged, thanks to Monsanto's ingenious marketing strategy. The strategy? Genetically engineer seeds to grow food crops that could tolerate high doses of Roundup. With the introduction of these new GE seeds, farmers could now easily control weeds on their corn, soy, cotton, canola, sugar beets and alfalfa crops—crops that thrived while the weeds around them were wiped out by Roundup.

In the nearly 20 years of intensifying exposure, scientists have been documenting the health consequences of Roundup and glyphosate in our food, in the water we drink, in the air we breathe and where our children play.

Eager to sell more of its flagship herbicide, Monsanto also encouraged farmers to use Roundup as a desiccant, to dry out all of their crops so they could harvest them faster. So Roundup is now routinely sprayed directly on a host of non-GMO crops, including wheat, barley, oats, canola, flax, peas, lentils, soybeans, dry beans and sugar cane.

Between 1996 - 2011, the widespread use of Roundup Ready GMO crops increased herbicide use in the U.S. by 527 million pounds—even though Monsanto claimed its GMO crops would reduce pesticide and herbicide use.

Monsanto has falsified data on Roundup's safety, and marketed it to parks departments and consumers as “environmentally friendly” and “biodegradable, to encourage its use it on roadsides, playgrounds, golf courses, schoolyards, lawns and home gardens. A French court ruled those marketing claims amounted to false advertising.

In the nearly 20 years of intensifying exposure, scientists have been documenting the health consequences of Roundup and glyphosate in our food, in the water we drink, in the air we breathe and where our children play.

They've found that people who are sick have higher levels of glyphosate in their bodies than healthy people.

They've also found the following health problems which they attribute to exposure to Roundup and/or glyphosate:

ADHD: In farming communities, there's a strong correlation between Roundup exposure and attention deficit disorder (ADHD), likely due to glyphosate's capacity to disrupt thyroid hormone functions.

Alzheimer's disease: In the lab, Roundup causes the same type of oxidative stress and neural cell death observed in Alzheimer's disease. And it affects CaMKII, an enzyme whose dysregulation has also been linked to the disease.

Anencephaly (birth defect): An investigation into neural tube defects among babies born to women living within 1,000 meters of pesticide applications showed an association for glyphosate with anencephaly, the absence of a major portion of the brain, skull and scalp that forms during embryonic development.

Autism: Glyphosate has a number of known biological effects that align with the known pathologies associated with autism. One of these parallels is the gut dysbiosis observed in autistic children and the toxicity of glyphosate to beneficial bacteria that suppress pathogenic bacteria, along with pathogenic bacteria's high resistance to glyphosate. In addition, glyphosate's capacity to promote aluminum accumulation in the brain may make it the principal cause of autism in the U.S.

Birth defects: Roundup and glyphosate can disrupt the Vitamin A (retinoic acid) signaling pathway, which is crucial for normal fetal development. The babies of women living within one kilometer of fields sprayed with glyphosate were more than twice as likely to have birth defects according to a study from Paraguay. Congenital defects quadrupled in the decade after Roundup Ready crops arrived in Chaco, a province in Argentina where glyphosate is used roughly eight to ten times more per acre than in the U.S. A study of one farming family in the U.S. documented elevated levels of glyphosate and birth defects in the children, including an imperforate anus, growth hormone deficiency, hypospadias (an abnormally placed urinary hole), a heart defect and a micro penis.

Brain cancer: In a study of children with brain cancer compared with healthy children, researchers found that if either parent had been exposed to Roundup during the two years before the child's birth, the chances of the child developing brain cancer doubled.

Breast cancer: Glyphosate induces human breast cancer cells growth via estrogen receptors. The only long-term animal study of glyphosate exposure produced rats with mammary tumors and shortened life-spans.

Cancer: House-to-house surveys of 65,000 people in farming communities in Argentina where Roundup is used, known there as the fumigated towns, found cancer rates two to four times higher than the national average, with increases in breast, prostate and lung cancers. In a comparison of two villages, in the one where Roundup was sprayed, 31 percent of residents had a family member with cancer, while only 3 percent of residents in a ranching village without spraying had one. The high cancer rates among people

exposed to Roundup likely stem from glyphosate's known capacity to induce DNA damage, which has been demonstrated in numerous lab tests.

Celiac disease and gluten intolerance: Fish exposed to glyphosate develop digestive problems that are reminiscent of celiac disease. There are parallels between the characteristics of celiac disease and the known effects of glyphosate. These include imbalances in gut bacteria, impairment in enzymes involved with detoxifying environmental toxins, mineral deficiencies and amino acid depletion.

Chronic kidney disease: Increases in the use of glyphosate may explain the recent surge in kidney failure among agricultural workers in Central America, Sri Lanka and India. Scientists have concluded, "Although glyphosate alone does not cause an epidemic of chronic kidney disease, it seems to have acquired the ability to destroy the renal tissues of thousands of farmers when it forms complexes with [hard water] and nephrotoxic metals."

Colitis: The toxicity of glyphosate to beneficial bacteria that suppress clostridia, along with clostridia's high resistance to glyphosate, could be a significant predisposing factor in the overgrowth of clostridia. Overgrowth of clostridia, specifically *C. difficile*, is a well-established causal factor in colitis.

Depression: Glyphosate disrupts chemical processes that impact the production of serotonin, an important neurotransmitter that regulates mood, appetite and sleep. Serotonin impairment has been linked to depression.

Diabetes: Low levels of testosterone are a risk factor for Type 2 diabetes. Rats fed environmentally relevant doses of Roundup over a period of 30 days spanning the onset of puberty had reduced testosterone production sufficient to alter testicular cell morphology and to delay the onset of puberty.

Heart disease: Glyphosate can disrupt the body's enzymes, causing lysosomal dysfunction, a major factor in cardiovascular disease and heart failure.

Hypothyroidism: House-to-house surveys of 65,000 people in farming communities in Argentina where Roundup is used, known there as the fumigated towns, found higher rates of hypothyroidism.

Inflammatory Bowel Disease ("Leaky Gut Syndrome"): Glyphosate can induce severe tryptophan deficiency, which can lead to an extreme inflammatory bowel disease that severely impairs the ability to absorb nutrients through the gut, due to inflammation, bleeding and diarrhea.

Liver disease: Very low doses of Roundup can disrupt human liver cell function, according to a 2009 study published in Toxicology.

Lou Gehrig's Disease (ALS): Sulfate deficiency in the brain has been associated with Amyotrophic Lateral Sclerosis (ALS). Glyphosate disrupts sulfate transport from the gut to the liver, and may lead over time to severe sulfate deficiency throughout all the tissues, including the brain.

Multiple Sclerosis (MS): An increased incidence of inflammatory bowel disease (IBS) has been found in association with MS. Glyphosate may be a causal factor. The hypothesis is that glyphosate-induced IBS causes gut bacteria to leak into the vasculature, triggering an immune reaction and consequently an autoimmune disorder resulting in destruction of the myelin sheath.

Non-Hodgkin lymphoma: A systematic review and a series of meta-analyses of nearly three decades worth of epidemiologic research on the relationship between non-Hodgkin lymphoma (NHL) and occupational exposure to agricultural pesticides found that B cell lymphoma was positively associated with glyphosate.

Parkinson's disease: The brain-damaging effects of herbicides have been recognized as the main environmental factor associated with neurodegenerative disorders, including Parkinson's disease. The onset of Parkinson's following exposure to glyphosate has been well documented and lab studies show that glyphosate induces the cell death characteristic of the disease.

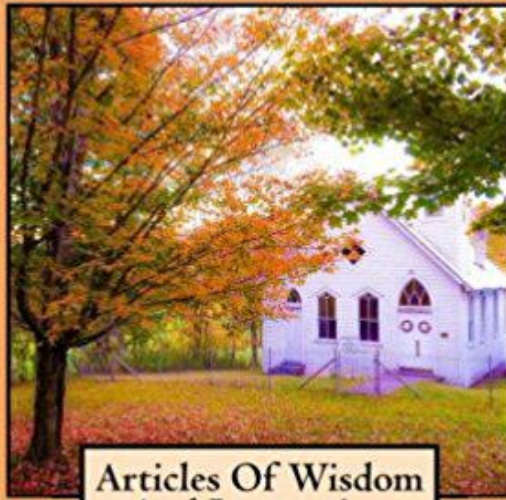

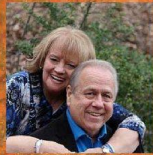
