Dr. Betty Martini - Senomyx is in Sucralose!

Dr. Betty Martini is the founder of the worldwide volunteer force, Mission Possible World Health International, which is committed to removing the deadly chemical aspartame from our food. This poison has brought more complaints to the American Food and Drug Administration than any other additive and is responsible for 75% of such complaints to that agency. From 10,000 consumer complaints FDA compiled a list of 92 symptoms, including death. They used to mail this list out, but now you can't get the list without a congressman or Freedom of Information Act request.

Dr. Martini has been awarded an honorary Doctor of Humanities degree for the work she has done and continues to do in alerting the world to the dangers of aspartame and other unhealthy chemicals and additives.

Dr. Martini has spent 22 years in the medical field. While working with a hematologist she supplied the CDC with reports on leukemia, which CDC said, were more than all the case histories submitted by the entire Emory University Hospital system combined, an indication of the low level of physician generated reports to the CDC. This reveals that only a small percentage of serious health threats are collected and statistically tabulated.

In 1970 Dr. Martini established a model for the nation by creating Physicians on Call, a network of five Emergency Care clinics in Atlanta, Georgia, staffed with medical doctors 7 days/24 hours. Services were without cost to the indigent. With a deep interest in traumatology she worked to build a trauma center in her mother's name, Eve Geller, who lost her life to breast cancer, but this did not materialize. She ran for Mayor of Atlanta in 1973.

Senomyx is an [American biotechnology](#) company working toward developing [additives](#) to amplify certain [flavors](#) and [smells](#) in foods. The company claims to have essentially "[reverse engineered](#)" the [receptors](#) in humans that react for taste and aroma, and that they are capitalizing on these discoveries to produce chemicals that will make food taste better. Senomyx develops patented flavor enhancers by using "proprietary taste receptor-based assay systems." These receptors have been previously expressed in [HEK293](#) cells.

History

Senomyx was founded by prominent [biochemist Lubert Stryer](#) in 1999. In May 2001, Stryer returned to his professorship at [Stanford University](#) and resigned from Senomyx, but continues to be the Chairman of the Scientific Advisory Board.

The company developed *Substance 951*, a [potentiator](#) used to amplify the [sweetness](#) of [sugar](#) in food products, thereby allowing the manufacturer to reduce the amount of sugar used.

Senomyx develops patented flavor enhancers by using "proprietary taste receptor-based assay systems." These receptors have been previously expressed in [HEK293](#) cells. HEK stands for human embryonic kidney cells. These cells, originally came from a healthy, electively [aborted](#) human fetus in the early 1970s. Using information from

the human genome sequence, Senomyx has identified hundreds of taste receptors and currently owns 113 patents on their discoveries. Senomyx collaborates with seven of the world's largest food companies to further their research and to fund development of their technology. [Ajinomoto Co., Inc.](#), [Kraft Foods](#), [Cadbury Adams](#), [PepsiCo](#), [Firmenich SA](#), [Nestlé SA](#), and [Solae](#) all collaborate with Senomyx, but do not specify where its additives may be found in their products.

Products

Senomyx's products work by amplifying the intensity of flavors. Because very small amounts of the additive are used, (reportedly less than one part per million), Senomyx's chemical compounds will not appear on labels, but will fall under the broad category of "artificial flavors." For the same reason, the company's chemicals have not undergone the FDA's usual safety approval process for food additives. Senomyx's MSG-enhancer gained the [Generally Recognized as Safe](#) (GRAS) status from the [Flavor and Extract Manufacturers Association](#), an industry-funded organization, in less than 18 months, which included three months of tests on rats.

According to Senomyx's website, it "received a positive review by the Joint FAO/WHO Expert Committee on Food Additives, which determined that there were no safety concerns with the use of the Company's savory flavor ingredients in foods. The positive assessment by JECFA is expected to expedite regulatory approvals in a number of countries, particularly those that do not have independent regulatory approval systems."

Two of Senomyx's newest innovations include a Cool Flavor Program that seeks to enhance cooling, menthol sensations, and a Bitter Blocker Program. According to Senomyx's website, the company is collaborating with Solae, the international soy ingredients supplier, "to develop new bitter blockers that better modulate and control bitterness in certain soy-based products." Senomyx has identified the receptors in the mouth responsible for sensing [bitter taste](#) and developed a chemical additive to knock out these receptors when eaten with [hydrolyzed soy protein](#) and other soy derivatives.

Be sure to read below the PepsiCo's Attorney's response to the Securities and Exchange Commission, in defense of Pepsi's use of murdered babies' kidneys, after stockholders filed a complaint against PEPSICO.



PepsiCo has come under fire from pro-life advocates because it has been contracting with a research firm that uses fetal cells from babies victimized by abortions to test and produce artificial flavor enhancers.

Now, the Obama administration is set to face more criticism because an agency has declared that Pepsi's use of the company and its controversial flavor testing process constitutes "ordinary business."

In a decision delivered February 28, the Security and Exchange Commission ruled that PepsiCo's use of aborted fetal remains in their research and development agreement with Senomyx to produce flavor enhancers falls under "ordinary business operations."

Debi Vinnedge, Executive Director of Children of God for Life, the organization that exposed the PepsiCo-Senomyx collaboration last year, informed LifeNews today that a letter signed by Attorney Brian Pitko of the

SEC Office of Chief Counsel was sent in response to a 36-page document submitted by PepsiCo attorneys in January 2012. In that filing, **PepsiCo pleaded with the SEC to reject** [a Shareholder's Resolution filed in October 2011 that the company](#) *“adopt a corporate policy that recognizes human rights and employs ethical standards which do not involve using the remains of aborted human beings in both private and collaborative research and development agreements.”*

PepsiCo lead attorney George A. Schieren noted that the resolution should be excluded because it “deals with matters related to the company’s ordinary business operations” and that “certain tasks are so fundamental to run a company on a day-to-day basis that they could not be subject to stockholder oversight.”

Vinnedge said she is appalled by the apathy and insensitivity of both PepsiCo executives and the Obama administration.

“We’re not talking about what kind of pencils PepsiCo wants to use – we are talking about exploiting the remains of an aborted child for profit,” she said. “Using human embryonic kidney (HEK-293) to produce flavor enhancers for their beverages is a far cry from routine operations

Vinnedge said PepsiCo also requested the resolution be excluded because it “probed too deeply into matters of a complex nature upon which shareholders cannot make an informed judgment.”

“In other words, PepsiCo thinks its stockholders are too stupid to understand what they are doing with the remains of aborted children,” she said. “Well they are about to find out just how smart the public really is when they turn up the heat on the world-wide boycott.”

Vinnedge is warning consumers to be on guard for the roll-out of PepsiCo’s newest beverage that claims to cut sugar and calories by 50%. The product is called Pepsi Next and is anticipated to hit the market in the coming weeks. Since PepsiCo stated that their goal with Senomyx is to produce new beverages with reduced sugars and calories, she wonders if Pepsi Next is the new Senomyx-PepsiCo creation?

“While fetal components are currently not in the final product, there is growing concern among consumers that it could happen in the near future. With the explosion of health foods on the market, there is nothing to stop companies from using fetal remains as protein ingredients,” she told LifeNews. *“Impossible, you say? Actually because of GRAS rules; (Generally Accepted as Safe); it might not even trigger FDA oversight. And that has consumers plenty worried about just what might be “next” from the industry.”*

She says the latest development makes [Oklahoma Senator Ralph Shortey’s SB1418](#) banning the sale of products that are developed with or contain aborted fetal remains critically important for consumer protection.

“We commend the Senator for his courageous move,” noted Vinnedge. “The public is already saying no thanks to all Pepsi beverages and Pepsi Next is just that – the “next” product to avoid.”

As recently as May, Pepsi ignored concerns *and criticism from dozens of pro-life groups and tens of thousands of pro-life people who voiced their opposition to PepsiCo contracting with biotech company Senomyx even after it was found to be testing their food additives using fetal cells from abortions.*

“The company’s key flavor programs focus on the discovery and development of savory, sweet and salt flavor ingredients that are intended to allow for the reduction of MSG, sugar and salt in food and beverage products,” **the Senomyx web site says.** *“Using isolated human taste receptors, we created proprietary taste receptor-based assay systems that provide a biochemical or electronic readout when a flavor ingredient interacts with the receptor.”*

Vinnedge explained, "What they don't tell the public is that they are using HEK 293 – human embryonic kidney cells taken from an electively aborted baby to produce those receptors. They could have easily chosen animal, insect, or other morally obtained human cells expressing the G protein for taste receptors."
