significantly different from what they would be for someone merely sitting at a window and gazing outward. So, the first decision to be made in planning a water garden is: Is it for contemplation from a window or patio or will it be the center of outdoor activity?

Looking at It

If the water garden is primarily to be part of the scenic view, it must be located within an aesthetically pleasing vantage of the homes living areas. From the kitchen window, living room sofa, or picnic table on the deck, it must be as satisfying to view the pond and its reflections as it is at closer range.

WHAT STYLE TO BUILD?

While personal choices present some options in materials used, the basic style or design of the water garden is all but predetermined by the style of the home and the existing landscaping. For a water garden to have not only a professional look but also to have that comforting feeling of belonging, it must be in keeping with its surroundings. If a home is distinctly formal and the landscaping simple and geometric, so, too, should be the water garden.

On the other hand, if the home is a ranch style, for example, and the landscaping more casual, a free-form, informal pond is more suitable.

Finally, in an expansive yard, especially one enhanced with native trees and flowers, an informal, natural wildlife design would be appropriate.



PLANNING FOR SAFETY

Safety is the single most ingo and factor in planning a water garden. No matter how beautifully constructed and landscaped, a water garden that invites accidents to unsuspecting visitors or children rapidly becomes a nightmare.



The accessibility of the pood is the most obvious safety factor to consider. Sitting a pond off the edge of a deck can result in catastrophic falls by guests, especially children. cally regulated, the legal repercussions in the unfortunate event of an accident may be comparable to those for a swimming pool. Homeowner insurance policies, too, may have stipulations to be satisfied.

If safety and legal considerations make a water garden too fraught with problems, other water features can be considered. (See Chapter IL.)

Electricity is a vital safety concern. Most water gardens use an electrically powered recirculation pump. Outdoor extension cords lying about on the ground can be very dangerous. The safest and best way to deal with electricity around a water garden is to have the service line buried underground up to a point near the pond. Even then, it should be connected via a contract circuit breaker designed to prevent fatal shocking. In the interest of safety, all electrical work ahould be performed by a licensed professional.

Even in cold climates, water gardens need not be deeper than 2 to 2% feet deep. In very cold climates with cooler and shorter summers, build shallower ponds so water can warm enough for good plant growth Winter over the plants in mot cellars

Another safety factor to consider is water depth, especially around the edges of the pond. Plan a foot-deep shelf or ledge around the edge of the pond to provide ease of exit. Make this shelf 18 to 36 inches wide to provide a safe footing.

THE PURPOSE OF A WATER GARDEN OR POND

Safety considerations may help determine the purpose of the water garden or pond. Should legitimate safety concerns make a four or five-foot-deep pond too costly, plans for a pond that includes koi may have to be altered to accommodate goldfish, which do not require such depths.

Formal ponds may feature fountains, precluding the addition of water lilies. Formal ponds need not be planted at all, while informal ones may incorporate a variety of aquatic plants that need varying depths for optimal growth.





to soften the sharpness of the elevation. And while siting the pond at the lowest elevation on the property may look natural because this is where water usually collects, pond flooding and possible contamination from rain run-offs are likely problems. Should such a site be the only available choice, construction plans should include drainage provisions. Good drainage is necessary to prevent the liner from bubbling up due to ground water pressure.

If the site is sloped, plan for terracing in a formal pond, and for possible terracing or water courses or waterfalls to take advantage of the elevation changes in an informal pond. Soil from the pond excavation can be used at the lower end to level the actual pond site, which must be wholly level to avoid uneven distances between

The lay of the land is an important consideration in order to avoid major excavation and restructuring of the entire yard. Obviously, a pond sited at the top of a ridge would look unnatural, although spoil, or the dirt from the excavation, can be used

If it is necessary to build up a portion of the ground, the new soil should be well compacted to prevent settling. Add clay to give extra support to looser soils.



It may be necessary to dig a sample hole in the area under consideration to determine the water table. Ideally, this is done during the winter to assess the amount of ground water and its level in the sample excavarion. In general, heavier, clavconcentrated soils hold more water and present more of a potential drainage problem. In such areas, drainage may have to be provided around the entire perimeter of a pond. Concrete constructions also may have to accommodate additional water pressure by being of increased thicknesses with appropriate reinforcements.

SELECTING A CONSTRUCTION METHOD

In spite of the fact that formal ponds are usually thought of in terms of concrete construction, they are easily made using liner construction methods. If concrete construction is the desired option, bear in mind that in some ways it is a more difficult method for the amateur. This does not mean that it is an impossible option. However, the amateur should confine his efforts to smaller ponds that are capable of being

POND CONSTRUCTION BASICS

FINDING AND MAINTAINING LEVELS

Water is always level, regardless of the lay of the land. Unless care is taken to establish an even grade for the pond edge all around. the pond will look lopsided. Most water gardens can be leveled with a builder's spirit level and a straightedge. A spirit level is a straightedge housing that encloses a bubble within a liquid. When the level is correct, the bubble will be centered. The bubble to the left or right depending on the grade is too high or too low. A handge is simply a long, straight, and priece of lumber. Stakes, pointed on one end, are tapped into the ground 6 to 12 inches behind the pond's edge. The first stake is designated the dation peg, the guide which all of the others will be made to agree with. The top of the datum peg will reflect the pond's upper edge or the anticipated water level. Smaller water gardens can be excavated by hand. Remove one shovel's depth at a time from the entire pond area. (To ease the cleanup job, have tarps nearby and put the topsoil and subsoil on them.) If a shelf is to be constructed within the pond, mark the edge around the excavation once the desired depth has been attained. The shelf's

ponds with gently sloped sides, most ponds should have nearly vertical sides, at least from the shelf to the top edge. This allows pond edging to be constructed with a minimum amount of visible pond wall. A slight slope in the wall can appear a definite bulge in the finished pond. Keeping the sides nearly vertical from the shelf down to the pond bottom makes for a more accessible

pond. Imagine trying to walk uphill on wet, slippery material; distinct, fairly level "steps" are safer and easier to use.

Excavate the very bottom of the pond at one end of the pond, for draining the Except for construction of larger natural pond by a submersible pump. This simple construction precludes the need for complicated bottom drains.

Be sure, also, that the depth takes into account any gravel or sand layers to be beneath the pond's membrane. At the pond's upper edge, which has already been established as perfectly level, creating an area just slightly below grade will allow for pond overflow during heavy rains.



Should the pond be planned for the lowest area in the yard where water normally accumulates, plan the excavation so the spoil is used to raise the perimeter of the pond. Tamp and compact this soil well, to prevent its settling in subsequent years. Likewise, ensure drainage provisions beneath the pond's membrane.

A pond excavated on a slope will require that the lower end be built up. Again, welltamped spoil from the excavation can be used. Generally, subsoil is more trable than topsoil. It may be necessary to meorporate soil reinforcement such as cla-

In areas with a high water table, pay special attention to drainage of ground water that might push the pond's membrane up from the ground. Generally, several inches of crushed stone placed over the entire pond bottom will suffice. Two or three inches of sand is placed over this.


In cases of a very high water table, it may be necessary to install drainage trenches across the bottom of the pond excavation. These trenches can be plugged into a peinteredrainage system that takes the waway from the pond area.

h drainage trenches may also be adle if surface runoff presents a problem. trench is dug between the runoff times and the pond to intercept and redithe water.

In either case, a trench is dug to the recessary depth with a one-inch-per-ten-Set drop in depth as the trench proceeds to the new drainage area. Chapter Three

PREFORMED PONDS



onds, usually made of strong as ABS, Acrylonitrile Butanene polypropylene or HDP, highpolythene, or fiberglass, are comavailable and easy to install. Although some are as large as twelve feet across, most are smaller, usually three to six feet across and 18 inches in depth. The very smallest are commonly only 12 inches deep. Being so shallow as well as so small, they may encounter problems with fluctuating water temperatures (which can stress fish) and with limited surface area (seriously limiting oxygen available for fish). It is very important with small preformed ponds to keep the number of fish lower than the normally recommended maximum stocking rate.

Plastic compositions cost less than fiberglass-reinforced or fiberglass constructions, but will not last as long. They may turn brittle, cracking and deteriorating within a few years. Even though the pond itself may be under warranty, the prospect of labor and the expense of dismantling and replacing the pond after only a few years may offset the greater cost of a stronger pond form.

Another factor to consider when selecting a preformed pond is the strength of the top edge. Because heavy rocks or paving that rest on a plastic edging may buckle and crack the side walls of the pond, reinforcing the top edge may be a good idea. A concrete foundation, as well, may be wise. (See Chapter 2 for construction of these reinforcements.) Fiberglass generally will not require such reinforcement, although it may still be desirable, to provide pond-edge stability. To avoid frustration and unnecessary expense if a plastic pond is chosen, be sure the top edge is level and not warped.



Preformed ponds are available in a variety of standard forms. Many offer planting shelves. In selecting one of these ponds, be certain the shelf is wide enough for a potted plant. Surprisingly, many such shelves are too narrow to be functional. Fiberglass ponds, though more expensive, can be designed and constructed to specification, thereby offering the opportunity for relatively simple installation and individually creative design. Two preformed ponds appear to be one large pond with a bridge crossover.

BASIC INSTALLATION OF A PREFORMED POND

A professional preformed installation involves more than simply outlining the pond, digging the hole, and backfilling around the pond. In the first place, the edge of the pond should be an inch or two above the surrounding ground to avoid surface run-off entering the pond and possibly contaminating or flooding the pond. Two

inches of sand should be placed in the bottom of the excavation, as well as on the surface of shelf excavations. This requires a decision prior to excavation; should the excavation be dug an extra amount for the sand cushion, or should it be dug to fit the actual pond shell, in which case the sand will elevate the pond above the surround. ing ground? If the latter, the ground base for the pond edging will already be firm; an underlayer of crushed stone or flat supporting rocks can easily be used to support the pond edging. Place dirt from the excavation or fresh topsoil in the surrounding area to camouflage the slightly raised elevation of the pond. If the pond will be installed in a turfed area, remo sod in 6 to 8 inch-wide strips to simi by groundmarking.

The job is considerably easier if no one is already fully level, but this may not always be. It is always wise to mark the levels with stakes before commencing any digging. Should the site present variations in level, monitor these guides throughout the excavation. (See Chapter 2.) A common option to correct level gradations is to use dirt from the pond excavation to build up the portion of the perimeter that is not level. Blend any accommodations into the surrounding ground to achieve a natural

appearance and tamp firmly to avoid settling and loss of the level. (See Chapter 2 for soil reinforcement methods.)

A symmetrically shaped pond can be marked with the preformed pond lying upside down on the site. Set an irregularly shaped pond on the site with a weighted string hung over the edge as a guide for marking the ground. Excavate a shovel's depth at a time across the entire outlined form. Compare the depth of any planting shelves with the shovel depth. Excavate the


Once the excavation is completed, use a spirit level to verify the perfect levels of the shelf and bottom areas. Clear away any loose soil, rocks, or roots. Smooth a two-inch sand cushion over the entire bottom and shelves, tamping and carefully checking that the levels are maintained. Keep a hose handy, spraying the sand as necessary. Dry sand will easily slide off the shelf, fill in the bottom edge of the next level, and make level pond placement impossible.

Set the pond into its excavation and check the level of the top edges as the pond is filled with an inch or two of water. As the pond fills, gently backfill the sides with sand. Use a hose with the water running slowly to wash or flush the sand into the side excavation. Fill the pond nearly full, simultaneously washing sand down the sides of the excavation so that backfilling and waterfilling are performed at about the same level. Continue to monitor the level of the ponds top edge.

Once the pond has been backfilled to the excavated level for the edge reinforcement and the top edge is perfectly level, the edging reinforcement can be installed. This may be a concrete collar, concretereinforced soil, or a layer of crushed stone, as necessary. (See Chapter 9 for edging completion.)

If a waterfall or water course is planned in conjunction with the pond, see Chapter 8 for procedure.

If any one product can be credited with revolutionizing water gardening, it would have to be the flexible liner. Although some enthusiastic would-be-watergardeners have used the least expensive and most readily-available materials, such as thin plastics or swimming pool liners, these liners are not suitable for water garden ponds. Even heavier grades of plastic sheeting puncture easily and degrade ouickly, often in less than three years. Vinyl swimming pool liners may be treated with algicides that prove toxic over time to fish and plants. Also, their light color appears artificial.

In the past, PVC liners were commonly used for water gardens. More durable than plastic sheeting, they could be expected to last 10 to 15 years. However, they needed special care to protect them from the degrading UV sunlight.

While butyl was the liner of choice, offering elasticity, durability, and ability, it was expensive. However, Firesto Rubber Company in the United State eveloped a comparable synthetic rubb ing, EPDM, ethylene propylere monmer, commonly called Pond This black, flexible liner with a 50 expectancy offers the same positive salities of the butyl and is priced compensely.

UNCERLAYS

Always use some form of protection or underlay between a flexible liner and the pond excavation. Some sources suggest old pieces of carpet. Joe B. Dekker of Aquascapes in Wycliff, New Jersey, has advocated the use of layers of newspaper to an inch thickness. Joe has noted that years later, in re-excavating a pond, the newspaper underlay had deteriorated into a powdery form called "gley." Joe notes the example of a fluid poured into dry flour-the liquid is repelled. The application of this principle in flexible liner construction means that small puncture holes in the liner do not result in water losses as the water is repelled by the powder-degraded form of newspaper on the excavation side of

should be added into the computation. The base figures come from the maximum width and length of the pond, regardless of shape. Add to each figure any depths from top to shelf, from shelf to bottom, or top to bottom, as the case may be. If the entire pond has a planting shelf, the depths of the top to the shelf and the shelf to the pond borrom may be doubled to account for the same measurements on the opposite side. The depth figures must account for the depths on opposite sides of the pond and must be added to both the width and length base figares. At least an extra foot should be added to the width and length figures to allow for an extra six inches around the upper edge that will come up behind the pond edging.





Soil-type permitting, the sides of the pond should be excavated as steeply as possible. This allows the top edging to best conceal the liner. Vertical sides coming down from plant shelves will make it easy to step out of the pond; a sloped side will be slippery and dangerous to walk on when it is necessary to be in the pond. Naturally, clay soils are the easiest to carve thelves and pond sides into. Should the oil be sandy or loamy, make the slope madual. This is appropriate only for very shallow or a very large water den. Wooden forms, concrete collars, rete blocks, or LineUps™ may be necessary to form the pond sides. (See Chapte

Although many commercial res show installation directly into de soil, such installations are not as durable of the long run as installations that include mitable side reinforcements to support heavy stonework and planting shelves. Fond sides may deteriorate beneath the liner, the sides may bulge outward from water pressure and pull the liner down, perhaps creating water losses, and stonework may settle and distupt the level of the pond. Even though the sides are excavated nearly vertically, only the heaviest of clay soils can be expected to hold its shape properly.

Likewise, make provisions at the top edge of the pond to accommodate the weight of any stone used. A clean, sharp edge is mandatory as stone will rest upon the level area. Particularly if crushed stone is to be used to provide support for stonework, some manner of edge formwork will

Once the hole is deep enough to accommodate the planting shelf, mark the outer edge of the shelf so it will be 18 to 36 inches wide. Then dig out the next level of the pond. The final depth should be sloped slightly to one place to facilitate pond drainage. The shelf and the pond bottom need not be perfectly level; they need be only level enough that plant pots can be set upon them. The upper pond edge, however, must be perfectly level.

Clear the excavation of loose soil and any protruding roots or loose stones. Smooth a two-inch layer of sand over the bottom. Spread sand on the shelf surface, but keep it suitably moist to prevent it from sliding down and creating a slope to the wall. Carefully fit an underlay over the entire excavation. If the underlay is our from several pieces, it may be necessary to anchor it in places with bricks or stone.

As the sand and underlay are installed. the pond liner may be unfolded to warm in the sun. This will help to ease any creases and fold marks. Buryl and EPDM Pond-Gard ** will not have fold marks. If the day is sunny and hot, black liners will be quite hot to touch. Thin garden gloves may be necessary to protect hands from burns.

Drape the liner gently in the excavation so that at least six inches is in excess fully around the perimeter. If the pond is so large that setting the open liner into the excavation is cumbersome, fold it in half and lay it into the hole, unfolding it gently. Remove any weights on the underlay in the process.

Although some pond installation directions suggest anchoring the liner loosely in the hole and allowing the filling water to pull it down, this may not be the wisest way to proceed. EPDM or buryl liners are not likely to develop weak spots from being stretched, but other liner materials may be

Most professional installers smooth and fit the liner into the excavation before adding any water. Whatever the shape of the pond, a flat piece of liner will need to be folded in spots to conform to the shape of the pond. While fitting the liner, combine folds to create as few as possible. Corner folds mitred inwards will appear smooth and flat from the outside. The more flexible the liner, the easier and better looking this will be.

Once the liner is folded and fitted, lightly anchor the excess at the top edges with stones or bricks. When the top edges of the excavation are fully level, begin adding the water. Monitor the folds and adjust them as necessary while the water level tises. Fill the pond as near to the top as desired to ascertain the level of the top edge and the settled fitting of the liner. The pond can be left alone for a day or two to allow for any liner settling. When it is time to finish the top edging, use the submerged recycling pump to remove enough water to work comfortably around the edge. (See Chapter 9 for edging completion.)

FLEXIBLE LINER INSTALLED BEHIND POND WALLS

Installing the liner behind the walls of the





pond lends itself to formal constructions, as well as to beautiful adaptations of informal, natural looking ponds. A formal construction might use bricks as the interior pond wall, or perhaps concrete blocks that are then sealed with black well proof sealant or neoprene paint. Informal ponds would have walls of stone, colors, or layered rubble.

The critical factor in more ded construction within the pond is mortar or concrete properto to involve several water completed in the first water change construction within the first water change construction within the first water change construction in the first water change construction within the process. Waterproof paint of sealant is another option.

Naturally, constructing walls of brick or stonework means that the walls will be totally vertical. Such weight needs adequate support to prevent it from settling into the ground. The best way to support such walls is to install a concrete footing all the way around the pond base. This footing can be extended as a concrete base for the pond bottom, too. (See Chapter 5)

Problems can later arise if the concrete footings are installed above the frost line. In central Indiana, for example, it is recommended that any concrete footings be three feet deep. Areas colder than Zone 5 require even deeper footings. Obviously,

this is deeper than the usual two feet planned for a water garden. Considering the time, expense, and expertise required to pour such thick layers of concrete, a layer of compacted, crushed stone and sand might be a practical choice.

Excavate the pond to the desired depth, and follow the procedure for concrete collar/footing construction described in Chapter Two, working to the appropriate frost-line depth, Once the concrete footing has cured, concrete block construction can be used up to the pond bottom. Once the walls are to the edging level, gently pull the liner up and weight it on top in order to backfill behind the wall. Professional backfill material is a lean morrar or lean concrete mix. This may be mixed heavily with soil backfill. Dry "cement soil," discussed in Chapter Two, may also be firmly tamped into the excavation. (See edging completion in Chapter 9.)

FLEXIBLE LINER CONSTRUCTED WITHIN WALLS

This construction method is similar to that of a wall built inside the liner. Excavate wide enough to accommodate double-wall construction and deep enough for a footing below the frost line.

Once the concrete footing has cured and will support the wall, construct a concrete-block wall. Maintain a perfect level up to the ground's surface. Build the wall on the back half of the footing.

Tamp the base of the pond well and cover it with sand. Place a protective underlay inside the excavation and fit the liner, folding as necessary. The fitting may be aided by spucing bricks around the inside bottom perimeter, around the back of any shelves, and around the top edge. Next, fit a second layer of underlay over the liner where the inner wall will sit upon the liner. Construct the inner wall with the stonework supported by the inner half of the concrete footing.


Before constructing the capping, backfill between the ground and the outer wall construction. This backfilling can be lean concrete (8:1 aggregate to cement), stiff concrete mixed in with the backfill soil, or ample dry concrete mixed in the backfill soil. (See Chapter 9 for edging constructions.)

TIP

Although the development of strong, flexible EPDM-type liners have virtually replaced the idea that a long-lived pond must be constructed of concrete, concrete may still be the construction method of choice. Successful concrete ponds, particularly large ones, are best constructed by professionals. The do-it-yourselfer should start out with a small concrete project, such as a foontain basin or a small water feature.

THE BASICS OF CONCRETE

Concrete is made of specific amounts of cement, sand, gravel, and water. Mortar is similar but has no gravel in the mix. Both may be purchased premixed in 80-pound bags. Each makes up 40 cubic foot. Water is mesh, or in larger or steep-sided areas, reinthe catalyst that causes the material to forcing rods and expansion joints. Bury harden; the less water, the stronger the mix and the stiffer it is to work.

A good mix, well-ramped, is primary. Weather is a critical factor: freezing conditions invite disintegration of the concrete

before it has cured, and very hot conditions may allow it to dry too quickly, likewise resulting in a weak, disintegrating product. Use acid-resistant cement in very acidic soil to prevent disintegration.

Concrete work should use reinforcing such reinforcements inside the concrete at least one inch from the outer surface. Am overlapping reinforcements should be ned together with wire.

TIP

Use a garden hoe to mix concrete and mortar in a uncellarmou. A common mistake is aching too much water; ach! more cernent mix to achieve a proper stiffness.

TIP

Installing a bottom drain may be more trouble than it's worth. So long as the pond bottom slopes to a deeper level or to a sump area, the submerged pump may be used to empty the pond.

TIP

Install any pipes or electrical wiring prior to the concrete pour. poured the same day to prevent weak joints that will crack with temperature changes. Cracks are difficult to repair with any assurance they work reoccur at the same place. Verify that any sealant/paint over-coating bonds well to concrete.

To prevent harm to fish, smooth the inner walls with a coat of rendering. Neutralize any concrete or mortar used around the pond or treat it with a sealant to prevent lime from leaching into the water and igopardizing the fish.

Even the most expertly built concrete pond is offered long-term protection if it is constructed within and upon a sturdy EPDM-type membrane. Establishing levels before starting and frequently verifying during the construction process is essential if the final product is to be perfectly level. Excavation should accommodate the following base and wall thicknesses:

4 to 6 inches for small ponds

6 to 8 inches for medium-sized ponds 8 to 10 inches for large ponds

Suggested Concrete Mixes

Foundations 1 part cement to 2 parts and sharp sand to 4 parts footings: aggregate

Pond bases 1 part cement to 2 parts and walls: sharp sand to 3 parts 1/4-1-inch aggregate

Waterproof 1 part cement to 3 parts rendering: builders' sand plus waterproofing agent

Additives

Here are some substances that can supplement a regular mix and the reasons for their use: Air-entraining agent—millions of tiny air bubbles are trapped in the concrete to prevent the concrete from cracking in cold climates. A concrete mixer is required.

Calcium chloride—this makes concrete set more rapidly than usual, thereby preventing freezing and expansion, which can fracture the pour.

Set-retarding agent—used in weather hotter than 90°F, to keep the concrete from setting too fast.

Plasticizer—this additive reduces the amount of water in the mix, preventing excessive shrinking and cracking.

Color agents—these should be a kied during the mixing process to color the concrete.

PREPARING THE SIT


Check and stake levels! Once in ad, the level of a concrete pond cannot without inviting weakened areas urring repairs, and frustration.

Be sure the excavation will aw for appropriate base and wall this asses. Spread a good layer of compacted hydrore into the pond base. The base and sides should be firmly tamped before constructing the concrete forms.

Be sure all supplies are on hand as you begin work. You don't want to near the end of construction and discover you haven't enough reinforcing material or cement!

CONSTRUCTING THE CONCRETE POND

It is assumed the excavation allows for perfectly level top edges and base and wall thicknesses, as well as that the excavation has been smoothed, the soil tamped firmly, and well-tamped hardcore reinforcement covers the base. Because a durable liner is



inded beneath the pond construcuitable underlay may also be

to begin the concreting at an early county hour in the day to complete the work within one day—both base and walls must be poured on the same day. If trucks of concrete are to be brought in, try to condinate delivery so that the work may proceed simultaneously. Be sure to have enough friends, relatives, and neighbors on hand to keep the process moving!

Concrete forms should be in place before the pour. If walls are to be constructed of concrete blocks, they may be constructed the day after the base is poured. However, the newly poured base will need to be protected with wooden planks.

Base Construction

Pour in concrete and tamp it down as you work backwards. Larger-size ponds will

merit the use of a tamping board. (See above.) One complete layer of concrete 2 to 6 inches thick is poured and tamped.

Next, position wire mesh or metal rods over the fresh concrete. Apply a second layer of concrete of approximately the same thickness. (If the second layer cannot be poured in the same day, roughen the surface of the first layer with a stiff brush while it is still wer. The following day, lay the reinforcing materials and thoroughly wer the first layer of concrete before applying the second layer.) The thickness of the two layers will depend upon the climate zonetemperate climates will do fine with 4 to 6 inches in total, while northern climates may require as much as 12 to 15 inches in total thickness.

TIP

Clay soil shrinks during dry spells. A layer of crushed stone between the clay and the concrete helps to prevent cracking.

TIP

Any reinforcing metals that protrude from concrete may oxidize and create leaks in the concrete form. the base reinforcements at the center level of the total thickness and then bring up the sides. The reinforcing mesh and tods should be fully constructed and tied carefully at any overlaps to allow the sprayed concrete to flow freely around them.

TIP

Texture and interest can be given concrete surfaces by using pebbles in the concrete mix. Hose the uncured concrete to expose the pebbles.

POURED CONCRETE WALLS

Vertical sides require the use of wooden forms known as shuttering. If the pond is informal with gently sloping slides, shuttering may not be required. However, even the informal pond that features heavy architectural structures weighing on the sides will require shuttering for maximum strength.

While the concrete base is still wet, roughen the edges with a stiff brush to ptovide maximum bonding potential with the walls. Any reinforcement that was used in the base should be upturned and extended into the bonding area of the walls. Prebent rods are available of 12 inches or more in length from the bend; these rods provide maximum strength at base-and-wall joinings.

Shuttering of the same thickness is installed and held in place with crosspieces. Be sure the top of the shuttering is perfectly level! The shuttering boards should not cut into any corners of the pond or they will create weak points in the structure. Vacuum out any debris that falls into your excavation during the work. Avoid this problem by lining the excavation with a plastic dropcloth. If a joint is formed between the pond base and the walls, keep it especially clean, hosing it if necessary.

As the side forms are filled with concrete, tamp the concrete down firmly with a wooden rammer. The top edge of the wall should be troweled perfectly level with the form on the pond's inner edge. Troweling with a slight slope back towards the surrounding ground facilitates edge construction.

Should the sides be uneven, fill the gaps with concrete by supplying additional shuttering. A gap left behind such an area can later be filled in with hardcore or a lean concrete mix.

CONCRETE BLOCK V LLS

Using concrete blocks to could the walls greatly simplifies a concretion. By their nature, however blocks are suited only to more blocks are suited only to more blocks are commonly used to struction, although larger, however, and the ware laid. Even greater strength is chieved with a double wall of hollow blocks and the area between them filled with concrete.

An advantage to block walls is that they may be installed the day after the concrete base is poured. Be sure to roughen the base edges where the blocks will join while the concrete is still wet. Reinforcing rods should extend out and up into the area where the blocks will sit to create a solid joint. The reinforcing rods should extend up the back or ground-side of the wall construction in solid concrete-block walls. Naturally, it is imperative that the perimeter base of the pond be perfectly level since concrete blocks are preformed. Extra care, as well, should be taken to maintain consistency in the thickness of the mortar between the wall blocks. (See Chapter 2 for mortaring of blocks.) When building up the block walls, remember to plan for a thick layer of mortar to embed the pond edging in. If necessary, replace the top layer of blocks with solid, engineering bricks to accommodate the height requirements.

To accommodate shelf construction, the bottom wall of the pond may be two or

three blocks wide and then drop back to a narrower width. Wider shelves can be constructed similarly, shaping the excavation to fit such constructions. A concrete footing is generally advised for support of the shelf walls if a concrete base is not provided.





SOLID-BLOCK CONSTRUCTION

This type of construction require that a good-sized cavity be left behind a wall construction for concrete backfilling. The wall-base joint should be reinforced with appropriate rods, as discussed above.

HOLLOW-BLOCK CONSTRUCTION

Properly reinforce joints between the base and the walls and between the walls and the edging. Fill the hollows of the blocks with a 3:2:1 concrete mix. Place rebar in the center of the hollows every 2 or 3

Dewall block construction requires the use of reinforcing rods or mesh in the cavity between the two walls, as well.

If you construct plant shelves of poured concrete, be sure to reinforce them adequately.

RENDERING CONCRETE

Rendering is important to give a smooth finish to the final surface of the concreted pond. Especially during spawning, fish may brush against the pond walls and suffer injuries that can develop into bacterial infections. A smooth finish is also more comfortable to work around while tending the water garden.

A rendering coat should be three parts sand to one part portland cement. It can be

applied within a day or two of the concrete's hardening. Waterproofing involves using an additive in either liquid or powder form-A black pigment can also be added to the mix to give the pond a natural, deep appearance.

A similar option is black, neoprene paint. This product should be fish-safe and applied in two separate coats, with a good drying period between applications.

COMBINING CONCRETE AND FLEXIBLE LINERS

The method of using a concrete pond form either beneath or over a flexible EPDM liner combines the best of both worlds. be as thickly constructed. Even though the concrete beneath may crack from weather or ground shifts, the liner remains supported and intact.

Such support is also possible simply by mixing a stiff concrete mix into a couple of inches of the pond excavation and tamping it firmly.

Whether a thin concrete shell or a concrete-reinforced soil base is used, an underlay will protect the liner from pressure abrasions caused by the water or the weight of people or plants.

WORKING WITH MORTAR

Mortar is very similar to concrete except it does not contain stone aggregate and therefore lacks the strength of concrete. Mortar is used to embed stonework or bricks and create seals between them. It is not an all-purpose glue. Any stonework used with mortar should first fit where it is placed.

Masonry mortar has a bit more flexibility than regular mortar mixes; it contains lime, which helps the mix resist cracking from temperature changes. Although mortar comes premixed in 80pound bags, in both the regular and the masonry mixes, it is less expensive to mix your own if large quantities are to be used. A standard mortar mix is 1 part lime. 2 parts portland cement, and 9 parts sharp sand.

Be sure it is thoroughly dry-mixed with a hoe or shovel before adding water. A large wheelbarrow is a convenient mixing container. Add water a bit at a time and mix with the hoe. The mortar should stand in peaks and create suction when a trowel is wiggled flat into it. If the mix is too thin, it will run; if it is too thick, it will not bond

Stop adding water just before you think


it's enough-it seems to turn runny with the last cup added. If the mix is runny, add more premix or more cement and sand. Alternatively, let the mix rest for half an hour to allow the water to rise to the surface and then pour it off carefully. If the mixture is not too runny, wait until the water starts to rise to the surface and begin working with the stiffer more from the bottom of the mix.

To get mortar into a joint fra the outside after the stone or brick is in pare, put a little mortar on the bottom ease of the trowel, near the tip, and smear it into the crevice with a push-and-wipe action. This is called "pointing up." Mortar should be uniformly recessed so the stonework appears to be jutting out from a recessed wall beneath it. Recessing can be performed up to 12 hours after the work has been done. After the mortar is crumbly, a wire brush can be used to finish the recessing.

Curing both mortar and cement allows the chemical action to be completed. The work must be kept moist for up to six days. Cover the area with plastic sheets or wet burlap. Once the mortar or concrete has set and won't wash or run out, moisten it with a hose twice a day, more frequently in hot

Even the neatest mortaring will have smears and stains on the workface. Some can be removed during the crumbly stage of curing with a wire brush. Stubborn stains can be removed with a solution of 1 part muriatic acid to 10 parts water.

Constructing a water garden with the side walls at least partially raised above ground level has several advantages. While the actual pond construction is not less work than an in-ground construction, the amount of excavation is significantly lessened. Maintenance of the water garden is easier and the pond is much easier to clean and empty as well. Children are less likely to fall into the pond. People with back problems or disabilities will have fuller enjoyment of the garden, and everyone can enjoy a closer look at the life within the pond.


Problems can arise with raised ponds. They are more susceptible to fluctuations in water temperatures, which may stress fish. Likewise, in cold climates it may be necessary to provide extra depth or insulation to prevent the pond from freezing solidly in the winter.

Because raised or semi-raised ponds require vertical sides for strength, it is usually best to construct them as formally designed gardens. However, using mortared field-stone or rubble in a circular form can accommodate a semi-formal amene.

BASIC PRINCIPLE F ABOVE-GROUND CONSTRUCTION

Excavation is the same as an in-ground pond. Levels should be cheeped and maintained at every stage of construction.

Concrete footings, adeq se hardcore,



or well-tamped, concrete-reinforced soil is necessary. Building the pond walls on soil alone invites collapse. Any pond built fully above ground should have a strong concrete foundation, to minimize potential damage from shifting soil and settling of the heavy, water-filled pond.

Neutralize come or mortar used in the pond itself or around the edging or treat it to prevent lime from leaching into the water. Before constructing the edge, leave a groove or space to accommodate electrical wiring if an electrical box is not built into the wall.

Outer walls should be at least nine inches thick to withstand water pressure, although a pond raised no more than 12 inches above ground may have but a single layer of bricks in the walls. Freezing climate zones should have well-reinforced, thicker walls or a double wall with insulation in the center.

Fiberglass preformed ponds are usually strong enough to require no additional wall support. Plastic preforms, however, will collapse without additional side support; simply piling soil around the walls is not enough.

The partially raised preform should be set in an excavation that allows the ponds shelf areas to sit level on the ground. A wall is then constructed to support the side walls above the ground.

BASIC CONSTRUCTION OF SEMI-RAISED POND WITH LINER

In excavation, allow for either single- or double-wall construction to the bottom of the pond. Solid or hollow nine-inch concrete blocks provide stable support. Render or plaster the outside of their visible upper section or cover them with bricks or stonework.

Install a footing twice the width of the wall and at least six inches thick into the pond bottom. If the frost line is too deep to make a concrete footing practical, dig the trench deep enough for a well-tamped base of several inches of crushed stone which the footing will be constructed on. Consult local building suppliers for recommended depths and thicknesses.

The in-ground wall may be constructed of concrete blocks and then more attractive decorative stonework used for the wall rising above ground.

Be sure the mortar used in the wall construction has sufficient time to cure and the walls are perfectly level before setting the liner. The bottom of the pond should be well tamped, padded with a few inches of sand, and then a protective underlay provided for the entire pond. Colder climates may require a layer of insulation, such as styrofoam sheets or wall/roof insulation under the liner or between double walls. Do not use insulation on the bottom of the pond.

Carefully fit the liner into the pond form and weight it around the top wall. Square-corner fitting requires weighting the smoothed bottom at the base of the walls. Smooth the liner flat against the walls and gather the excess loosely in the corners. Trim the membrane to overlap only to the

outer wall edge. Use one hand to tuck the excess liner into a fold against the pond wall to create a straight-edged fold up the corner. Repeat this process on the adjoining wall section and in the remaining corners. Circular liner fittings proceed in the same manner, with folds created as needed. In each fold, the excess liner is folded in to the wall. Fill the pond with a couple of inches of water, to be certain the liner is well fitted and won't pull down into the excavation when the pond is full. Filling the pond completely verifies that the walls are perfectly level and the water level is the same all around the pond perimeter. If the water level is not equal all around the pond perimeter, fix the outer walls to be level before applying the edging.

SEMI-RAISED CONSTRUCTION WITH PREFORMED PONDS

This form of construction is easiest with a symmetrically shaped preformed shell. After checking the site levels, mark around the shell's outer dimensions. (See Chapter 3.) Be sure the excavation allows for two extra inches of sand cushioning. A perfectly level concrete footing or a base six to nine inches deep may also be constructed for the shell to sit upon, if necessary. The sand cushion would then be placed on the concrete. Be certain that the shell, when set in its excavation, is perfectly level at the top edge.

Construct a level concrete footing as a base for the outer wall per locally recommended specifications. (See Chapter 2 for concrete footing and wall constructions.) After the wall has cured, backfill between the wall and the pond form with sand. Add water to the shell during the backfilling to prevent the sand from lifting the shell and spoiling the established level.

TIP

It is better that concrete footings are too wide for wall support than too narrow, risking the wall's stability.





Earth pond construction is not suitable generally for water gardens, which are small relative to the half-acre or more "farm ponds." Because resources are limited on these constructions, this chapter serves primarily to direct further research.

Probably the most important consideration is who you hire to do the excavation. It is not enough simply to find somebody with

a bulldozer, backhoe, or other equipment, lust as with the garden, levels are extremely The excavator must be ader oth the use of level equipment and to ful creation of a pond shell. Strang it may sound, some excavators will simple up the spoil around the edges and unt that height as part of the pond depth. And some excavators will check the levels of the pond bottom rather than the top edges! It is wise to check references and to see completed projects before committing to hire an excavator.

Other considerations in selecting an excavator are his knowledge and concept of drainage and the existing watersheds. Chances are you will have to arrange to haul away dirt, too. Be sure to have an onsite place to store your topsoil. Check around for the current prices of nonpulverized topsoil by the truckload and then offer it to your excavator, if you have no use for the topsoil, in exchange for a reasonable reduction in his price.

THE CLAY-LINED POND

Because clay is not one hundred percent watertight, pond construction must be large enough to allow for probable water loss. Water loss can occur from aquatic plants growing in the pond, tree roots that grow to the water source and form fibrous root masses, tunneling animals, and underground springs that fluctuate in flow. Water loss can also occur if field drainage riles are broken during construction. This allows water to enter from one end of the broken tile and leave by the other. (Plugging up such breakages can cause flooding problems "upstream.")

Clay that is encountered on-site should be very pure for water retention purposes. Blue clay usually indicates the presence of liquid, running sand, or water itself nearby.

It is important never to let the clay dry out during construction; apply soil or gravel over the clay to prevent drying. If the clay is dry, use a rototiller to powder up a five- or six-inch layer that will act as a sealant when the pond is filled.

Begin excavation at the deepest point with a method called "clay puddling," which is used to attain more water-retention capacity. This method involves compacting the wet clay as it is worked, either with feet, rammers, or mechanical compactors. The excavation is then filled partially as work proceeds outward from the center.

THE BENTONITE POND

Bentonite is a form of clay that is formed by fossilized volcanic ash. It is named for Fort Benton, Montana, where it was first discovered. Sold in powdered form, it expands when moistened, to provide a waterproof seal.

Problems with its use involve high or fluctuating water tables, the presence of chalk or gravel, invasive tree roots and shore-side vegetation, as well as the pres-

ence of ducks and geese. Obviously, conditions must be ideal if bentonite is to be used successfully. Hence, the subsoil of the site must be tested before a decision is made. If the subsoil contains chalk or limestone, calcium ions will replace the bentonite's sodium ions and seriously impair the expansive and sealing capacity of the bentonite.

If bentonite is the method of choice, the soil must first be prepared. The excavation depth should allow an additional foot for a layer of soil that will cover the bentonite. The base of the pond, as well as the sides should be clean and smooth, fairly dry, and free of organic material. Excavate the sides to a gentle slope since the bentonite will not remain stationary on a steep slope.

Spread bentonite evenly over the entire pond surface at a density of 20 pounds per square yard. A rototiller may be used to work it into the subsoil to a four-inch.

depth. Then use a compactor over the entire surfacing. Spread one foot or more of subsoil or topsoil before filling the pond. As the moisture penetrates to the bentonite layer, the swelling and sealing occurs beneath the soil cover.

Depending on the application rate, the oil can coar the gills of fish and cause them to suffocate. The manufacturers recommend removing any valuable fish before introducing the treatment.

Since it is a white oil, it will turn the water white for anywhere from a few days to several weeks. Likewise, it will cling to submerged aquatic plants and cause them to take on a whitish tinge. Neither side effect is permanent.

The product can also collect dust that appears as a whitish scum around the pond shore. This is easily removed with a swimming pool skimmer.

Although ESS-13 will not stop runningwater leaks, it is an effective method of seepage control. Applied in the compaction stage of construction of an earth pond that has no viable source of fresh water, it can mean the difference between a dry hole in the ground and a long-lived pond or lake. The natural pond at Disneam Water Gardens is home to many fish and exotic fowl.

Chapter Eight

WATERFALL AND STREAM CONSTRUCTIONS

TIP

The wider the waterfall spillway, the less the force of the water flow.

One that determines the type of moving enter feature to include is water lilies. Since lilies are not happy with moving or splashing water, any feature that might disturb them must be at a distance and of such minimal effect to allow the lilies to bloom freely. While moving water is enjoyable to watch, its primary attraction is its sound. Both lilies and the sound of moving water can coexist if the sound is created in an upper basin with the actual entry into the pond at a minimal flow. This can be achieved by a two-tiered waterfall with the upper level providing the sound and the lower level providing a wide-lipped basin, good for a biological filter area of plants such as watercress, that dissipates the force of the entry-water into the pond. Waterfalls present a constant source of water loss. They may be constructed of heavy stones that, although perfectly set initially, shift in time with ground settling and

weather changes. Even moulded plastic or fiberglass watercourse sections have the potential to overflow or to develop leaks. What works today may not work next summer when plants have grown, furry green stuff clings to rocks, or silt has collected in Phon to H. Nach

LINED WATERFALL CONSTRUCTION

Once the waterfall shell has been dug out, lay in the liner and run some water through ir to check levels and possible leakage points. Even though the levels may be fine at this point, monitor them throughout the construction.

Start at the bottom or entry-level into the pond. Rocks over which the water falls should be flat with a smooth, crisp edge at the front. If they don't have a crisp edge, the water may not fall cleanly over them. but rather dribble into the water. 

Pockets of soil behind rock edges and in nooks and crannies of the construction will support moisture-loving plants. Be certain the plants selected do not object to moving water. Bear in mind the ultimate size of plants chosen for these places. Heartshaped bittercress, for example, may be only a few inches rall when planted, but will attain a height of two feet by midsummer.

Stones at the side of the construction can be used to help direct the water flow over the falls. A stone placed into the water flow channel will change the direction and increase the force of the flow. If the rocks are being permanently affixed in the channel, experiment with the hose before making final placements.

Any significant water drops where the water will splash should have amply high walls to prevent water loss by redirecting the water back into the flow to the pond.

The top of the waterfall should be constructed to prevent the hose's visibility. Depending on personal preferent the initial water flow from the hose can controlled. Bill Dawden of Coastal Pond Supply has recommended that a watertight cavity be constructed at the top of the waterfall. He suggests that the outlet hose be directed backwards within this cavity so that the water flows up against the back wall of the cavity and then gently flows outward and over the construction. Likewise, a perforated bar-outlet can be directed away from the pond to allow for a more gentle flow.

It is tempting in constructing a waterfall to mortar everything in place. This can present two major problems. First of all, it creates a constant source of lime in the pond water that may be dangerous to fish.

TIP

Water needs to gain speed to fall clear of a spillway. Providing a slight distance before the spillway helps prevent a wet well

An interesting alternative to concrete or mortar is quick-drying, poly foam, available from most building supply centers. The foam comes in a can and may be sprayed into any gaps between or behind rocks or around the edges of the construction, as well as between rocks and the liner. The foam actually bonds to the liner better than mortar. Joe B. Dekker recommends keeping a bucket of sand handy during the spraying operation. Wear gloves during the application and keep a stick handy to push

the foam back into crevices and gaps. Quickly toss a handful of sand onto the surface, to camouflage its white or golden-yellow color. Check previously sprayed areas after a few minutes as bubbles of the foam may ooze through the sand. Once they have dried, these bubbles can be twisted or cut off with a razor blade. If the bare white of the foam is obtrusive, a dab of non-toxic paint can finish the camouflaging.

FORMAL WATERFALLS

Formal waterfalls are excavated like a staircase and constructed as detailed above, except that the materials used are of an appropriate nature—bricks, concrete, slabs, flagstone, or smooth paving slabs to achieve the strict geometric structure of formal designs.

PREFORMED WATERFALL

Although limiting creative endeavors, preformed waterfall units are readily available in several variations that may be combined into a water course feature. They are available in plastic, fiberglass, cement, and reconstituted stone.

Excavate the area as necessary, compact the soil, and line it with a good layer of sand, placing a piece of liner over it. Set in the courseway section, back line beneath it with sand as needed, and the liner up






arcs. the edges. Conceal the liner and mould of call with soil and rocks.

Place and fiberglass units may require anchoos to stabilize them within their setting. This may involve the intrusion of rock formations around them, which will aid in making them look more natural. It is difficult to fully camouflage such features, even though manufacturers assure us that in time, mosses and such naturalize the feature. It can be a real challenge to cover them with enough rock to look natural while not disrupting the already perfected flowing levels.

Cement and reconstituted stone constructions may look a bit more natural. Set them in water to check the water's pH for leached lime. Coar them with a limeneutralizer if necessary. Several units can be combined to create a lengthier water course. Each unit must overlap the lower and be set firmly in a level position. If heavy rocks are used, be sure the soil beneath is reinforced to prevent settling in time. Be sure the water flowing through the course has at least an inch above it to contain it; some molded units do not have enough depth to accommodate rock limings or plants within them.

Preformed waterfall units are suitable for smaller water features. Installation of a single unit is fairly simple. Make sure the unit sufficiently overlaps the pond to direct the water. Arrange the desired camouflage around the unit to naturalize it in its setting. (Have an extra piece of liner beneath and around it.)





STREAM COURSES

Stream courses are a variation of the waterfall construction. However, the longer the stream course, the more possibility of variety-a short series of waterfalls, occasional small pond areas, an island in the stream, and bog plantings. The stream is constructed in a series of level sections connected to lower areas via falls with the overall stream area smaller than its pond source. If it is necessary to top off the pond reservoir to start the stream moving, the bottom pond will flood when the pump is shut down.

A naturally appearing stream course fol-

lows nature's guidelines-running in valleys, meandering around rock outcroppings, tumbling through narrow channels, and opening into calm pools. Natural streams have gently sloped sides, while canals have high, raised banks enclosing the waters. The hose that carries the water from the bottom pond to the top of the stream should be buried to the top of the stream, where it is made to appear to flow from a rock grotto.

Because the longer the stream section, the deeper the top end of that section must be, it is less trouble to excavate the stream as a series of short sections. Vary these

Close attention to the levels of each section ensures that the water flows through the course in the center of the bed. The water should attain a two-inch depth before tumbling into the next stream section. Using a level, establish the two-inch depth at the spillway end of a section so that it is below the surrounding ground level. Then, work back up the section to establish the depth for the water's entry into the section so it is the same level upon entry and exit. The section may be at its deepest at the head of the section.

The type of stream course being constructed determines the shaping of the excavation. Dig a stream meandering through a grassy area as a shallow "V." Rock-lined streams will be excavated as a straight-sided "U" so the rocks can be stacked upon each other to lead from the





stream to the bank. A bog-type stream excavation combines a planting-shelf area on the perimeter of a deeper, rock-lined area through which the water runs. Before determining the depth of the excavation. experiment with piles of rocks to estimate the depth needed to accommodate a particular design.

CONCRETE STREAM COURSES

Constructing the stream base of concrete can be lenging in frost-prone zones. Great lity of the concrete is achieved tions are kept short. the excavation are kept very gently sloped. forms other than the excavation itself may not have to be used.

Concrete blocks on a poured concrete base can be used for the side construction. Nine-inch concrete blocks are a good height as well as a good length for short sections. (See Chapter Five to adapt concrete block wall construction.)

Cut a "U"-shaped excavation to provide enough depth for the constructed form and its crushed stone underlay, approximately three to six inches, plus six inches for rocks in the bed, plus as much as 12 inches for planting shelves to put several inches of soil on. Each section should be constructed in its entirety at one time. The end of the section, where the water will spill over to the next, should be approximately three inches below the rest of the rim to allow for the flow. If plant shelves are desired, the width of the stream section could be approximately three feet across. Otherwise, the excavation will be 12 to 18 inches across. While the concrete is still wet, use a wire brush to roughen the spillway area and the entire bottom of the construction.

sufficiently, soft concrete can be applied to a roughened spillway area so flat spillway rocks can be pressed to the necessary level and angle. Mortar in place rockwork that will be incorporated in the spillway area to prevent water from running underneath.

Likewise, unless the water has a strong, ample flow through the stream course, it is likely to run under rather than over any stones put loosely into the stream bed. This is especially true if the pond reservoir is small. Since the bottom of the construction was roughened while the concrete was still wet, a thin layer of concrete or mortar will affix the bed stones. Use mortar between them as necessary. Create a plant shelf along the sides by cementing in fourto six-inch rocks along the edge to contain the soil.

Once the cementing is completed, cure, render, waterproof, and neutralize the entire structure before introducing the loose stones and soil in the planting area. (Cover the soil with a two-inch layer of pea gravel and assorted smaller rocks to contain the soil after planting.)

LINED WATER COURSE

Because stream courses are more vulnerable than a self-enclosed pond, use the strongest, most flexible liner available-

If rocks are not affixed to the liner, folds should face the opposite direction of the water flow to avoid slowing it down.

Areas of the courseway to support heavy stones should be reinforced beneath the liner either with concrete pads or with several inches of crushed stone. Spillways especially require such reinforcement.

PREFORMED STREAM COURSES

Excavation is performed in a series of level three inches lower than the rest of the rim. steps, starting at the bottom where the stream will enter into the pond. 

Chapter Nine

POND EDGINGS



The first consideration in choosing pond edging is the overall design of the pond and the yard. Formal designs rely on the harmony and stability of strict geometric shapes. Stone slabs, granite, slate, bricks, or same-size cobblestones work well. An informal pond can have turf or bog edging, as well as fieldstone, flat stones, bricks, or wood.

Another factor in making an edging choice is its function. Will there be foot traffic on the edging? Will people want to sit on the edge? Even if people aren't meant to stand on the edge, it may be wisest to construct your edging with standing in mind—for safety's sake. Even though many pond kits come with directions showing a simple placement of loose or stacked stones around the pond, such edgings can be

precarious.

Provide reinforcement, too, for any weight, as rain-soaked ground will cause uneven settling of stones over time. In the case of light stonework, a few inches of crushed stone may be sufficient, as would a thin layer of concrete or stiff concrete worked into the top few inches of soil.

Concrete collars are often recommended for steep-sided ponds, as well as for ponds using heavy stonework. Likewise, plastic preformed ponds that require the edging to rest primarily on the surrounding ground to avoid collapsing the side walls may need a concrete-reinforced perimeter.

Avoid selecting soft rocks that crumble easily. Although less expensive, they begin deteriorating in a short time, producing unsafe conditions and leaching excess minerals into the water.

Put a gap in concrete ponds between the pond walls and the edging to avoid winter cracking where the pond water expands at a faster rate than the pond itself. A thin layer of plastic sheeting with the edging mortared onto it and the bulk of the edging weight resting on the surrounding ground will work.

Remember, mortar does not bond well to liner materials. It is important that the foundation in the adjacent ground ade-

quately support and and the edging.

Whatever the edging of ce, if mortar or concrete is used, be sure to waterproof it or treat it for lime. A good period of rainy weather may result in excessively high pH levels in the pond.

Unless the pond is large enough to accommodate gently sloped sides to the desired maximum depth, the side walls must be practically vertical. Vertical sides allow the liner to be better concealed by the slightly extended coping. (See Chapter 2 for establishing a sharp pond edge.)

Before starting the edge construction, use a spirit level and straight edge both around the pond perimeter as well as across its width and length. Be certain the pond is completely level. Remember to plan for space in the edging for electric cables and waterfall hoses, if necessary.

Bring up the liner behind the edging to prevent surface runoffs from flooding the pond, as well as to help prevent pond over flow. Sloping the edging slightly down and away from the pond helps prevent runoff contamination. Also, having the pond edge set a few inches above the surrounding grade is an adequate deterrent in low-to-normal rainfall areas. Set the pond edge four inches above the existing grade in rainy areas. (See drainage options in Chapter Two.) Backfill the area behind the liner edge wark soil, stone, mulch, or sodded turf.



FORMAL EDGINGS

Formal ponds look best with the water level at or just below the edging. This effect, called brimming, requires an absolutely level capstone. Mortar used for setting the edging should be thin at the pond edge so it is not conspicuously visible. Additional stability is granted by increasing the mor-

tar thickness towards the back of the edging, but do not tilt the edging in towards the pond at ground level.

PAVED EDGING

Paving is heavy. A concrete collar provides the best support for this type of edging, although a single layer of paving may be adequately secured upon a several-inch layer of crushed stone.

The paving slabs should be embedded in mortar for stability. Because smaller pavers can be tilted by a person's weight, use larger slabs where people are likely to stand. Likewise, the slabs should be large enough to overhang the pond by an inch or two.

Small cobbles can line a gently sloped pond and be extended up out of the water to form the pond edge.

Scott Bates recommends embedding rock edgings in a concrete mix:

- 2 shovelsful portland cement
- 4 shovelsful Mason/sharp sand
- 1 shovelful Swift Set™
- 2 shovelsful pea gravel

Mix with water and Fortifier Acrylic™ bonding agent (mixed 1 qt. to 5 gal. water). This technique allows facing the liner from a shallow shelf up over the pend edge.



BRICK EDGING

Bricks offer a variety of choices in pondedging material and can be used for both formal and informal ponds. Single brick edging does not require any great reinforcement for support; a few inches of crushed stone is usually sufficient. Because bricks cannot be mortared to liner material securely, some sort of stable surround should be provided for their anchoring.

An interesting variation on the use of bricks is to mortar stacked bricks onto the liner from the planting shelf up to the ground level where the edging row is constructed. Perfectly level shelves are required for this construction.

It is best to avoid using bricks with holes as they invite grass and weeds, besides cracking and crumbling in freezing climates. Engineering bricks—the thin, solid pavers designed for outdoor use—can be used as an edging and also extended into a paved area surrounding the pond.





Bricks used as an edging for a concrete pond can be mortared directly to the pond walls. However, to allow for expansion, they shouldn't be mortared into any surrounding paving.

ROCK EDGING

Rocks are probably the most commonly used pond edgings, and the most commonly misused edgings. It's very easy to string them around the pond perimeter and create the traditional "rock necklace." But a little variation in rock sizes and random nearby placements achieves a natural appearance.


A well-reinforced, shallow shelf around the pond can support stacked rocks that spill out into the surrounding ground, with various sizes providing interest. A large rock can peek through the water. Smaller rocks can fill between larger ones. An added benefit of such a construction is the water-access provided to birds. An extra layer of padding between the rocks and liner should be used.

It is best to avoid laying the pond edge loosely. The edging should be set in a concrete or mortar mix that is well supported by several inches of crushed stone or a substantial concrete collar.

The liner should be brought up behind the rocks and anchored by more rocks, concrete, or substantial backfilling of soil and plants. Stones scattered about appear

most natural when they seem to be embedded in soil. Avoid cementing the edging rocks to rocks that extend into the surrounding area in a cold climate zone to prevent undesirable, additional stress on the pond walls.


The main problem with using rocks or stones as pond edging is the difficulty of getting them to overhang the pond edge to provide sun protection to the liner. Rocks big enough to do this may be out of proportion to the pond size. Providing sufficient reinforcement beneath them can create additional work and expense. Large cobbles or fieldstone, however, can be split in half or lightweight, reconstituted stone or fiberglass hollow rocks with lips that hang over the pond edge can be used.



GRAVEL AND PEBBLE EDGING

A larger pond can be edged with gravel or pebbles. Even if this method is used in only one section of the pond, the birds that visit the pond to bathe and drink will be grateful. Naturally, this edging treatment is informal. The biggest problem with this type of edging is the silt, debris, and algae that may accumulate in the gravel. Cleaning the gravel is usually required every couple of years. Sharp, angular gravel should be avoided and liner protection provided if it is likely anybody may walk upon the gravel.

The lined pond requires that the liner be brought up above the pond's water level and then buried back into the surrounding soil into a trench of sorts, the "trench" being filled with pea gravel or other suitable small stone. The gravel then extends from shallow water up onto the dry land. A submerged stone wall can also be built upon a planting ledge, the area behind it backfilled with the gravel. The natural look of the pebbled beach can be extended into the pond itself by covering the bottom of the pond with an inch or two of the same pebbles. Added advantages of this construction are the foraging area provided for





The use of cobbles and stone along with a shallow bog area creates a natural pond. fish, a medium for the growth of submerged plants, and the concealment of particulate matter that settles on the pond bottom.

Fixed-form ponds such as preforms or concrete forms can include pebbled beaches by the same backfill method. If the planting shelf is too narrow to support a store wall, dark colored engineering bricks may be used.


WOOD EDGING

Using wood or timber ed is possible, but does present problem. Chemically treated wood may contamt ate the pond water. These toxins may not be immediately toxic, but they can build up in the water, eventually killing fish. Another problem is that wood exposed to water tends to warp and rot. Because of this, they shouldn't be permanently affixed to the pond.

Wood edging, however, can be nailed to a fiberglass support plate that is installed in a groove around the pond's edge. It may also be affixed to a wall or concrete support with stainless steel straps.

Short timbers of varied heights can be embedded in a layer of concrete set on a shallow shelf around the pond. Bring the liner up behind the timber edging and secure it over concrete haunches or stones and bury it in soil. Bring turf or decorative gravel to the edge.

If the feeling of wood or timber is de-



sired, a lider concrete structures that look like loop and wood. Treated properly for lime, such products may achieve the desired appearance with a longer life than real wood.

TURF EDGING

Turf or grassy edgings are particularly appropriate to informal and wildlife ponds. They do require a ban on the nearby use of lawn chemicals and a tender hand with the mowing. Grass blown into the pond produces a mess and can result in thick, green water. It may be necessary to cut the pondedge grass by hand.

LineUps⁷⁹ facilitate this type of edge construction. (See Chapter 2.) Similar constructions can be made of wood forms or the liner sharply dipped back into the soil over a concrete haunch.

Because small water gardens can be plagued by green-water problems as the soil nutrients of the bog garden leach back into the pond, the garden can also be created as a separate construction immediately adjacent to the pond.





PUMPS AND FILTRATION

PUMPS AND MECHANICAL FILTRATION

Although a clear water garden is possible without the use of a pump or filtration system if the pond is kept clean, the number of fish is kept within the recommended stocking rate, and the pond has enough submerged grasses, most water gardens use recirculating water. With the growing popularity of the gardening, many new pump and filtrate developments are appearing in the pump place. Most notable, perhaps, is a submersible pur black in manufactured in black to blend in the extreme of the pond against a black line.

The only oxidation precaution with these pumps is to not use two dissimilar metals in close proximity within the pond; the softer metal will oxidize.

Even though many authorities still recommend turning the pond water over within a specific time-frame, a clean, ecologically-balanced pond does not require rigid management. Except in very small ponds, water flow can be based on the requirements of the water feature.

Fountain assemblies and additional filtration units may be attached to the submersible pump. Photo courses of Bens



Pump size is generally calculated based on the gallons per hour output at one foot of lift or height. Most manufacturers offer a chart that shows the GPH at additional incremental increases. An additional factor to consider is the length of hosing from the pump to the water feature. For every ten feet of hosing, resistance within the hose produces a decrease in output of one foot of lift. (See Appendix for pump chart and recommended hosing sizes.)

To determine the pump size required, fill a five-gallon bucket with water and experiment with its flow over the waterfall. Determine how many seconds it takes to achieve the desired appearance, divide 60 seconds in a minute by that number of seconds, and multiply by five. This will give the number of gallons per minute needed for the desired look. Multiply this figure by 60, to determine the number of gallons per hour required. Figure the height of the waterfall lift, plus any adjustments for the length of hosing, and compare the desired GPH with the pump chart to determine exactly what size pump is needed. (A one-foot high waterfall with a six-inch wide spillway would require a 600 GPH pump, for example, Increasing the spillway to 20 inches wide would require a pump of approximately 2000 GPH.)

Generally, the size of hosing used from the pump should be the next size up from the diameter of the pump outlet. This will require an adapter which should be affixed with stainless steel clamps. The larger the hose diameter, the more gentle the flow. If the flow is too strong, increasing the hose diameter may produce the desired effect.

Restrictor clamps can make minor adjustments in water flow. The clamps must be affixed to the discharge hose of the pump to prevent stressing and burning the

pump. A tee connection avoids clamps and diverts some of the water to another water feature, such as a spouting ornament or a small fountain.

Most pumps have a screen apparatus over the pump's intake to keep out debris and baby fish or tadpoles. These screens may clog and stress the pump during the spring and autumn months. A 200 GPH pump, for example, needs approximately 40 square inches of screening. Wrapping the pump in fiberglass screen gives more particulate filtration. Larger filter and assemblies are readily available, for flose the debris from the screen of the stably, and rinse the foam media is a speeded.

Electric

Electricity of water are a dangerous combination. Sever use an extension cord to the pond. Many local ordinances require the use of a licensed electrician for any installation work; check the regulations before starting construction.

Ourlets should be at least four feet from the pond and housed in waterproof casings. Protect the entire circuit with a ground fault circuit interrupter. A lock on the cord to prevent any inadvertent disconnection is advisable.

The main electrical cable should be armored and buried at the depth specified by local ordinances. Cable over 100 feet will have a significant drop in voltage. A pump can be plugged into a lighting outlet, but should be separately switched and fused; this requires at least a four-core armored cable.

If a slight tingling is felt in the pond

water or if the fish are unduly agitated and jumping, turn off the electricity and check the system.

Generally, the smaller the pond, the more likely a recirculating pump is needed. Although fish do get most of their oxygen from water surface exchange, a small pond may require supplemental aeration from a pump.



Surface Skimming Filtration

Many years ago, Joe B. Dekker of Aquascape Designs in Wycliff, New Jersey, designed a pond filtration system based on the surface skimming filtration systems

used in swimming pools. It is most effective in ponds of at least 4×6 feet and with submersible water garden pumps producing at least 750 gallons per hour.



Materials Needed

One 30 gallon, heavy-duty, plastic trash can

one 10 × 9 inch piece of plastic, 1/4 inch thick

11 %2-11/4 inch bolts with nuts
5 screw-in hooks

one tube of RTV single-component silicone

one nylon mesh laundry bag
11/4 inch flexible black hosing to reach
from pump to waterfall
submersible water garden pump of at least
750 GPH

hose adapter for hosing, if required optional: filter foam to fit inside dimension of trash can, spray foam for camouflaging lid

Construction Procedure

Preliminaries

- 1. Excavate a hole adjacent to the pond edge to accommodate a 30-gallon, heavy-duty, plastic trash can so the pond's water level will be at the mid-point of the centered 7 × 8 inch cut-out 1½ inches from the top of the can.
- 2. Layer the bottom of the excavation with 2 to 4 inches of well-tamped, crushed
- Provide a shallow trench from the can to the waterfall for routing the flexible return hosing.

Preparing the can:

- 1. Mark and cut out a 7 (vertical) × 8 (horizontal) inch rectangle 1½ inches down from the top and centered on the front of the can.
- Cut a slot from the top edge for the pump hose and electrical cord to exit the can above the water level when the lid is replaced.
- 3. Cut brackets from 1/6 inch thick plastic: One at 10 × 11/4 inches Two at 7 × 11/4 inches
- 4. Set the can into the prepared excavation.
- 5. Apply a ¼ x ½ inch line of RTV singlecomponent silicone around the face of the can's cut-out. Press the pond liner to the can face and hold it firmly to the silicone by bolting on the three brackets. Brackets and can edges should be predrilled. (The silicone will require a minimum of 24 hours

- to cure before water can be run through it.)

 6. Use the can's cut-out as a guide to cut the liner across the top and down the sides for a matching hole. Fold the liner flap to the inside of the can.
- 7. Attach two screw-in hooks approximately eight inches down from the top of the can on each side of the cut-out and two screw-in hooks one inch down from the top of the can on each side of the cut-out. Attach another hook one inch down, to the center of the opposite size of the can. The laundry bag will hang the five hooks with the pond liner within the bag.
- 8. Connect the flexible hos are the pump and place the pump in the pump om of the can. Route the hosing and po's electrical cord from the can.
- 9. Optional foam may be confit inside the can over the pump for adminal small-particle filtration.
- Attach the edge of the mesh bag onto the hooks while keeping the slack to a minimum.
- 11. Spray foam may be sprayed onto the can lid and sand tossed onto it for camouflage. Flat paving stones can also be used to hide the lid.

Using the Skimmer Filter

- During operation, maintain the water level at one-half to one-third the way up the opening of the cut-out.
- 2. Clean out the nylon bag as needed. Hose clean any foam media as needed.

BIO-FILTRATION

Bio-filtration makes use of nitrifying bacteria to change organic wastes and ammonia into nitrite and then into nitrates. Since the bacteria need moving water and oxygen to survive, it is necessary to use a water feature and/or a natural filtration system such as Richard Schuck's Ten Percent Solution.



pumped into a series of chambers for inechanical filtration of debris and particulate matter and bio-filtration by the nitrifying bacteria growing on various media forms.

The key to such out-of-pond systems is the rate water flows through them. Since the first chamber is designed to collect particulate matter, the water must flow at a rate that allows the particles to settle within the chamber, ideally one gallon per minute per square foot of chamber area. If space is a problem, baffles or brushes can be added to slow the water movement through this chamber. Site the intake hosing to this initial chamber in the upper third of the tank. Clean this chamber frequently to lessen the bio-load on the rest of the

system

Henry and Carole Reimer of Reimer Waterscapes in Canada report a simple, but effective, bio-filter. Inside the pond, set un a 200 to 500 GPH pump with an attached particle filter on the water intake. OTHER WATER FEATURES



FOUR TINS

Water fourthins provide both sound and movement in the water garden. They are best suited to the formal garden or to a fish pond since water lilies do not grow well when exposed to constant water movement or splashing by a fountain.

Keep surrounding landscapes simple and restrained for the most effective use of fountains. Tall vertical jets look best against a vertical backdrop, while low, arching jets look best with rounded shapes behind them.

Site fountains where wind will not scatter their spray. This can cause excessive water loss besides detracting from the fountain's appearance.

Although several jets can be operated by the same pump, affixing each jet to its own control valve controls their appearance.

Water will flow the strongest through the jet nearest the intake valve or through the straightest pipe.

Several fountains set up within a pond can be operated from a single largediameter pipe that runs the full length of the features. Smaller pipes connecting from the main pipe then share even pressure.

Small-holed jets can clog and require cleaning. A good mechanical particulate filter attached to the pump's intake will. help. Since severe clogging stresses the pump, set it on a riser to prevent intake of dirty water from the pond bottom.

Fountain Basins and Wall Fountains

A plumbed hand pump provides moving water. Provide H. North Fountains and piped statuary require only a basin or reservoir. A shallow basin at least as wide as the fountain easily holds and conceals a small pump. Maryland Aquatic Nurseries has developed a plastic basin fitted with a grating approximately two-thirds of the way up from the basin bottom. Lightweight decorative media, such as clay balls, cover the grating up to the edge of the basin. The basin is filled with water that recycles through a carved featherock. Plants grow hydroponically within the media; although the media may be attractive, the concept is safe for use around children.

Spouting statuary set within or attached to the sides of broad basins with a small pump concealed beneath the water allows enjoyment of the sound and movement of water. Floating aquatics, such as water hyacinth or water lettuce, may be grown in the basin.

The main concern with these types of water features is that their area is well-

compacted. Placing them on concrete or flat-stone pavers provides stability.

Wall fountains offer an interesting water option. Water circulates from within a small basin by a tiny submersible pump through a spouting or overflowing ornament. These features can be mounted on a garden wall or on the back wall of a pond. Conceal the water delivery and electrical supplies for the fullest aesthetic enjoyment.



STEPPING STONES IN THE POND

Stepping stones can be used in both formal and informal ponds. Stone squares that match or coordinate with the pond itself or long slabs bridging the water suit formal pond designs.

Informal ponds offer more freedom in



size and composition of stepping stones.

Since heavy stones exert weight on the pond bottom, suitable reinforcement should be provided in the pond base. Concrete pads or footing reinforcements beneath a liner or flat stones set upon protective pads on the liner serve to spread out the weight of pedestals and stepping stones.

Pedestals for stepping stones can be constructed of concrete blocks. If the stones will be walked on, it is advisable to mortar the blocks together for extra stability. The pedestals should raise the stepping stones an inch or two above the water level to prevent slippery algae growth. Any concrete or mortar work should be limeneutralized.

BRIDGES

For maximum effectiveness, place bridges where their use appears logical. Install adequate footings beyond the rim of the pond for maximum stability. Handrails should be located closely enough together that a small child cannot slip through.

If the bridge is constructed of wood, leave a slight gap of up to a quarter of an inch between each plank to prevent water from collecting and creating a slippery surface. The height should always be above the highest water level in the pond.

ISLANDS

Large concrete or lined ponds can include an island. Providing reinforced concrete footing under the liner or wide slabs on the pond bottom prevents damage to the pond membrane.

The island itself can be constructed of

concrete blocks. To counter water pressure, solid blocks should be used or the hollows filled with concrete. The blocks may be mortared together for stability. Render and treat the blocks for lime, perhaps with a black water scalant that will make the sides less conspicuous in the pond. Fill the interior of the island with soil and plant it. If the island is more than two feet deep, the bottom perman may be filled with rubble. Feature and provide the island on the island.

WHISKEY BARREL OR TUB GARDENS

Whiskey barrels, wine casks, or tub gardens can be used effectively as patio or lawn planters set above the ground or sunken within it. Such gardens set above-ground in cold climates need to winter the plants and fish indoors. A plastic tent allows their wintering over if the tubs are set in the ground. These small planters are especially useful for growing loruses.

Whiskey barrels or wine casks must be lined to prevent leaching of tannic acid and alcohol residues that will kill fish and plants.

BOG GARDENS

Bog gardens are constructed the same way as a lined pond. The excase has should be 18 inches deep and the liner is mover a layer of sand. The liner is manctured throughout the bottom for drainage. Up to four inches of crushed stone or pea gravel is placed in the garden and eight to 10 inches of soil filled on top. Edging is placed around the garden, bog plants set into the soil, and water added to the edging.

Bury a perforated hose in the soil with the end capped and the hose connected at the soil's surface for watering the garden as necessary. Control mosquitoes in shallow water with Mosquito Dunks¹⁰, floating bacteria that kill mosquito larvae.

Nymphaea-Hardy water lilies are true perennials, experiencing winter dormancy. They can be wintered over in a pond provided the lily root does not freeze. Most water lilies require at least five hours of sunlight. The surface coverage, or spread, of a lily is generally twice its depth in the water. Dwarf and pygmy lilies require only 6-10 inches of water over the plant's crown. Medium-sized lilies require 10 to 20 inches, and large lilies do best with 16 to 32 inches of water over the crown. Hardy water lilies are available in white, pink, red, yellow, and changeables—generally yellow to bronze or red over the four-day life-span of the blossom. Their blooms open by midmorning and close in the mid-to-late afternoon. A lily leaf's life span may be only two weeks in the summer, but others are produced throughout the season.

Tropical water lilies require a minimum temperature of 70°F and above, lots of sunlight, and regular feeding for their profuse

bloom. They usually hold their flowers well above the water and are available in a sparkling array of colors, including blues and purples. They require only 6–12 inches of water over the plant's crown. Like their hardy cousins, these lilies need at least five or six hours of sunlight daily, although some of the blues seem more tolerant of less. Day bloomers are open from midmorning to mid-afternoon night bloomers are open from late afternoon to midmorning of the next day.

Lotus—Like hardy water the less, lotuses are fully hardy so long as the subers are not allowed to freeze. Stand desized lotuses may grow to five feet, and dwarf forms may reach only three feet allowers, they need as large a pot as possible. Research suggests they need feeding only once or twice a season. They require temperatures above 80°F to flower, as well as long, sunny days.

Nymphoides (Water Snowflakes, Fringed Water Snowflake, Floating Heart)—a group of tropical plants grown much like water lilies with floating leaves and short-lived yellow or white flowers, some varieties with fringed edges. The plants spread by long trailing runners that will root into other plant pots when available. The common yellow-flowering peltata (Floating Heart) is the only hardy one in the group. The others must be grown as annuals in temperate zones.

Marginal Plants

These plants may be grown with two to six inches of water over the plant crown on plant shelves or on pedestals within the water garden.

Acorus calamus (Sweet Flag, comes in variegated form, also)—Iris, straplike foliage with nondescript "flower." Grows 2-nearly 3 feet tall from a shallow-rooted, creeping rhizome that requires a broadmouthed pot. Fully hardy in zone five with no special winter care.

Acorus gramineus ssp (Japanese dwarf sweet flag)—Available in cream or yellow variegations. Grass-like appearance to 18 inches. In zones 5 and colder, it should be wintered over indoors as a houseplant.



Butomus umbellatus (Flowering Rush)— Triangularly shaped, rushlike blades to 3 feet in height with umbels of pink flowers held above the leaves in mid to late summer. Does not do well in hot climates or in small pots, although it is among the slower to propagate. Hardy to Zone 3. Water-sensitive plant, Neptunia aquatica

Canna ssp.—Tropical, lush-colored flowers in mid-to-late summer and elegant, broad, pointed leaves may be grown in 2 to 8 inches of water. Winter over indoors as houseplants in colder climates.

Colocasia (Taro or Elephant Ear)—

Cyperus alternifolius (Umbrella Grass)— Tropical, parasol·like umbels grow to 3½ feet; it can be wintered over in frost areas either indoors as a houseplant or its pot sunk below the ice level in the pond. Available in both dwarf and variegated forms. Glyceria maxima ssp. (Manna Grass)— Available in variegated form, but tends to revert to common green. Prevent this by cutting out green stems. Grows to 2 feet and is highly invasive. Fully hardy.

Iris laevigata (Japanese Water Iris)—Not to be confused with Iris ensata (formerly known as Iris kaemferi), this iris is fully hardy and will grow to a good 2 feet with 2–4 inches of water over the plant crown. Blooms late spring to early summer for 3–4 weeks, flowers short-lived, but blooming in succession. A slightly short variegated variety is available. Many recolors and bybrids are available.

Menyanthes trifolia (Bog Bean)—Hardy, scrambling habit that is slow to establish, but then becomes rampant after 3 or 4 years. Prefers shallow areas and edges of the pond or bog garden; offers delicate, white fringed flowers in late spring to early summer along with its three-leafed foliage.

Myosotis palustris (Water Forget-me-not) A dainty plant growing to only 6 inches, it may be grown in 2–3 inches of water over the plant crown. Dainty blue flowers in early summer may set seed. Hardy through 20ne 5.

Myriophyllum aquaticum (Parrot's Feather)—A delightful plant that also functions as a submerged covgenator. Its whorled, feathery, lime-green tips floot at the water's surface. Must be wintered over beneath any ice in cold climates.

Pontederia cordata (Pickerel Weed)-Shiny, spear-shaped leaves on fleshy stems produce spires of clustered purple-blue. white, or pink flowers in mid-to-late summer. 

The canadensis form has small leaves on brittle stems; the densa or anacharis form has longer leaves but is not as hardy. Lagarosiphon major is often sold as elodea crispa or anacharis, which has longer, dark green leaves that curl back on themselves as they grow along the long stems. Eleocharis acicularis (Hairgrass)— Bright green, grassy plant that grows only 6–8 inches forming a carpet on a pond bottom prepared with sand or soil.

Eichhornia ssp. (Water Hyacinth)— Swollen, air-filled leaf bases give these tropical glossy plants buoyancy. Lovely lilac blooms last but a day. Hydrocharis morsus-ranae (Frogbit)—A delightful, dainty plant of glossy, air-puffed leaflets that spread by runners.
